## **SOUTH EAST FORESTRY HUB**

### **STAKEHOLDER WORKSHOP 2025**

### PARTICIPANT NOTES

Wednesday 26 March - 9:30am - 2:30pm

25 people gathered at the Civic Centre in Bega to explore the future of the South East Forestry Hub. The focus question for the workshop was:

How can we ensure that South East Forestry continues to flourish towards a productive and sustainable future?



#### **WELCOME & INTRODUCTION**

SEF Hub Chair, Mal McComb welcomed us to the day and handed over to facilitator David Newell who outlined how the day would run and principles that would support us to work well together. These were:

#### **HUB OVERVIEW**

Hub Manager Rob de Fegely gave an overview of where the Hub is up to and what projects are currently underway. Rob spoke of the need to take stock and review where the Hub is up to, and look to the next 2.5 years. He outlined the need that exists for forestry products into the future and the need for the industry to be sustainable. Rob highlighted the importance of building public awareness about forestry and providing extension opportunities for landholders.

## ROUND 3 - What objectives will best guide the South East Forestry Hub now and into the future?

The group interrogated the current Hub objectives and gave input into what should be improved, added and dropped - to guide the Hub's activities for the next 2.5 years.

#### **CURRENT OBJECTIVES**

- 1. **Consultation** to consult with a wide range of stakeholders and interested parties across the Hub region.
- 2. **Map Current Forest Resources** undertake broad scale mapping of the forest resources within the Hub region by tenure and management.
- 3. **Future Forest Investment** identify opportunities for future investment in forest resource development.
- 4. **Investment Business Case** identify and support business cases for the investment in new infrastructure.
- 5. **Future Plantation Development** determine the potential for future plantation expansion (softwood and hardwood).

#### WHAT ARE YOUR KEY TAKEAWAYS FROM THE DAY?

- We need a vision for future forest operations that is palatable to all stakeholders or as many as possible
- A lot of our focus on defining and working towards a safe and healthy forest

- Learning about the breadth of the SE Forestry Industry
- Unified industry perspective is not really enough
- Reinforced that forestry has a key role in the region's future/circular economy but lots of barriers in the way that need to be by-passed, dealt with
- Advocacy of value that forestry contributes to the broad population is #1
- Forestry is actually very forward looking in terms of sustainability and using by-products, but maybe public perception of forestry is not up to date
- There is momentum pointing towards a successful transition to productive and sustainable forestry
- There's a lot of ideas and thoughts amongst the industry and the Hub that make the process worthwhile
- Hub brings resource and structure but task ahead is significant
- What the Hub will be focusing on over the next 2.5 years what the priorities are and/or should be
- There is a broad cross section of ideas to progress the Hub's objectives
- Great forum for idea sharing
- Lots of unknown organisations/people with great insights
- Need to work together for the future of the industry and Forest NSW
- Profiling and engaging wider in hub region tourism, mountain bikes, Indigenous
- Connections and links with other stakeholders about activities in the area

- There are large barriers that are not easily broached

- Forestry NSW and Pentarch are aware of the poor condition of our native forests in the area Forest health is a major concern

- Understanding of communication pathways to get best bang for bucks for the industry eg, where can we help or get help
