AGREEMENT TO ABIDE BY THE RANGE RULES

I agree to abide by the following RANGE RULES in effect at the time of this membership, and any future changes to these rules. I understand that disregard of any of the following rules or the intentional performance of any unsafe, destructive, or discourteous act while on Air Capital Gun Club property shall be just cause for cancellation of membership and/or permanent denial of use of the club facilities.

Current Range Rules

- 1. PROHIBITED ON CLUB PROPERTY:
 - A. Persons under the influence of alcohol or controlled substances,
 - B. Fully automatic weapons.
- 2. <u>Membership Identification</u> must be displayed by all persons (including guests) using the ranges. Guests, children, and Junior Members, must be accompanied by an adult member who is responsible for their conduct.
- 3. Behind the firing line: Guns must be holstered or cased unloaded. No dry firing or gun handling is allowed except in approved areas during scheduled matches.
- 4. On the firing line: Guns must be grounded or benched unloaded, with actions open and magazines removed so long as anyone is forward of the firing line.
- 5. Personal vehicles are to be parked in authorized areas behind the firing lines of the ranges. The last person out the gate must lock up.
- 6. Purpose and use of ranges:

Gram Pankratz Smallbore Rifle and Pistol Range (Maximum distance 50 yards) - (West range) For .22 rim-fire only. Approved targets must be posted.

<u>Harold Beighley Pistol Range</u> (Maximum distance 50 meters) – (Center Range) For handguns and .22 rim-fire rifles only. Approved targets must be posted. Rifles may shoot paper targets only.

Bob Tompkins Rifle Range (Maximum distance 100 yards) – West side, East range. For rifles and pistols. Approved targets must be posted. Rifles may shoot paper targets only.

Silhouette Pistol Range (Maximum distance 100 meters) - (East side, East range) For pistols and rifles using approved pistol cartridges only. Approved targets must be posted.

Approved targets include paper targets, authorized steel silhouettes and poppers but do not include cans, bottles, boxes and other breakable items.

- 7. Eye and Ear Protection must be worn by everyone using the ranges.
- 8. Clean UP: Each member is expected to return the targets and frames to proper storage and clean up his firing point before leaving.
