THE LONG-TERM SUPPORT BY THE FOUNDATION HAS LED TO THE DEVELOPMENT OF AN ARTIFICIAL PANCREAS SYSTEM, BREAKTHROUGH STEM CELL RESEARCH, STUDIES INVOLVING THE RELATION OF TYPE I DIABETES TO OTHER AUTOIMMUNE DISEASES SUCH AS CELIAC DISEASE, AND DEVELOPMENT OF A PROGRAM TO TEST THE PROBABILITY OF A CHILD DEVELOPING DIABETES.
