Important Documents and Tax Dates

Your end of year investment statements are now available online.

As you prepare for tax season, we want to remind you that your tax documents are not available yet, but should be available by late February.

- Required Minimum Distributions calculations will be completed by **January 31**
- Form 1099-R, which reports last year's retirement withdrawals will be

ready by **January 31**

- Form 1099-DIV and 1099-B, which report your capital gains and dividends will be ready by **February 15**

Financial Markets 2025: Onward and upward

Key takeaways as we leave 2024 behind and begin a new year.

- Stocks delivered exceptionally strong returns in 2024 due to a rare “Goldilocks” combination of strong earnings growth plus rising price-earnings ratios.
- 2025 may be less likely to see a repeat of this combination. Instead, stock gains may be more likely to track earnings growth (which continues to look robust).
- One key risk to watch for in the year ahead may be a re-acceleration in inflation, which could occur if the economy re-accelerates.
- Stay the course with a long-term investing strategy
