All nominees are first nominated by readers and winners are selected primarily based on voting results. However, the editorial and compliance team will also review votes and the businesses. The nomination period is from May 1-31. The voting period runs from July 1- October 31st. Candidates are required to complete an application before they're considered and followed up with an interview phone call. Candidates cannot pay a fee to be included in the research or the final list of those included.
