- 1) Call meeting order. The meeting was called to order by President Uresti at 5:51 p.m. Dr. Antonio Uresti, Mario Flores, Janie Gaytan, and Juan Tito Palacios were present, and a quorum was established.
- 2) To receive public comment and conduct the public hearing/open forum to allow interested parties to address the Board of Commissioners and be heard regarding the proposed property tax rate setting. There were no public comments.
- 3) Conclude Public Hearing on Tax Increase. The public hearing was concluded at 5:54 p.m.
- 4) To consider and adopt the District 2026 Budget. The proposed 2026 budget included reimbursements to the County, Contract for Fire Services, Legal and Audit services and office supplies for a total of two million three hundred and sixty thousand dollars (\$2,360,000). Commissioner Flores made a motion second by Commissioner Palacios to approve the District 2026 Budget as presented. The motion passed by a vote of 3 to 0 with Commissioner Uresti abstaining.
- 5) To adopt the District 2025 Ad Valorem Tax Rate for Maintenance and Operations. Commissioner Flores made a motion second by Commissioner Palacios to approve by resolution the 2025 Ad Valorem Tax Rate for maintenance and operations at \$0.10/\$100. The motion passed by a vote of 3 to 0 with Commissioner Uresti abstaining.
- 6) To adopt the District 2025 Ad Valorem Tax Rate for Debt Service. Commissioner Flores made a motion second by Commissioner Gaytan to approve by resolution the 2025 Ad Valorem Tax Rate for Debt Service at \$0.00/\$100. The motion passed by a vote of 3 to 0 with Commissioner Uresti abstaining.

- 7) To adopt the District 2025 total Ad Valorem Tax Rate. Commissioner Gaytan made a motion second by Commissioner Flores to propose that a 2025 maintenance and operations tax rate be adopted at a \$0.10 per \$100 of taxable value and the debt service rate be adopted at a rate of \$0.00 per \$100 of taxable value, for a total tax rate of \$0.10 per \$100 of taxable value. The motion passed by a vote of 3 to 0 with Commissioner Uresti abstaining.
- 8) Adjournment. Commissioner Flores made a motion second by Commissioner Gaytan to adjourn the tax adoption meeting. The motion passed by a vote of 3 to 0 with Commissioner Uresti abstaining. The meeting was adjourned the meeting at 5:59 p.m.
