**Facility:** Indoor, 25 yard, 10-Lane, competition pool ranging from 7'0" -7'1" in depth. Lanes are 7'4" wide with 6" Kiefer Wave Eater Lane Lines and Kiefer Elite Starting Platforms. CTS Backstroke Start Wedge system may be used. Starting blocks are 29.5". Two courses may be used if dictated by timelines or at the discretion of meet management. Warm up and cool down lanes will be available. The meet host will ensure the required course dimensions.

**Timing System:** Colorado Timing System will be used with manual back-up buttons and back-up timers for each lane.

**Rules:** Official 2025 USA Swimming and WI LSC rules shall prevail at this meet.

All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned/approved meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. This includes participation as a member of a relay. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.

**Eligibility:** All swimmers must be currently registered with USA Swimming. Swimmer's age as of November 7, 2025 shall determine their age group for the meet.

**Meet Entry:** Entry will be accepted from the following teams that attended last year's November Invite and the additional invited teams (COHO, EBSC, FMC, MSS, WILD, PAC, PX3, RA-IL, RA-WI, SWMKE, STRM) **beginning on Tuesday, October 14 at 10am CST.** Entries will open for all other teams if space permits **beginning on Tuesday, October 21 at 10am CST through midnight, Thursday, October 30<sup>th</sup>** You will receive confirmation that your entries were received and accepted. Once accepted, changes (as space permits) and time updates will be allowed through Monday, November 3rd.

**Entry Limit:** Senior Prelim/Final Session participation is limited to a maximum of 3 individual events and 2 relay. Sunday's Senior Session is limited to a maximum of 3 individual events. 12&Under Timed Final Sessions participants are limited to 4 individual events and 1 relay. Friday session limited to two events subject to the timeline.

**Disabled Swimmers:** Teams are encouraged to inform Meet Director and Officials of any special needs swimmers prior to the start of warmups. If any accommodation and/or modifications are needed, teams must submit the WSI Para Accommodation Form

**Format:** The meet will be a combination of prelim/final events and timed final events as listed in the Schedule and Order of Events. Prelims events will be combined ages. Final individual events will be divided into 13-14 and Senior. Senior events are ages 15 and over.

Friday events are all positive check in. Positive check in will close at 4:30pm. All Friday events will be swum fastest to slowest

Finals Format – The top 20 of each gender and age group (13-14 and 15&O) will advance to finals in individual preliminary events with the fastest 10 swimmers in the Championship A finals and the next 10 swimmers in the Consolation B. The top seeded 10 swimmers in the 500 freestyle by age (13-14 and 15&O) and gender and the top 10 seeded relays of each gender will swim in finals.

Check in – All A finalists must check in prior to the start of the B final in the event they are competing.

Sunday PM Session - Will include 50's of each stroke in the survive and advance skins format. Each round (except freestyle) will be swum between heats of the 200 events in the timeline following each 50 skins event. Final heats of all events in this session will be announced.

Skins format –

- Round 1 will include all athletes
- Round 2 will be the Top 6 fastest from Round 1
- Round 3 will be the Top 3 fastest from Round 2

Pre-seeded events (prelims and timed finals) will have no penalty for failing to compete in prelims or timed finals.

Finals events:

- a. A swimmer qualifying for a consolation or championship final will have 30 minutes after the announcement of the preliminary results for that race in which to scratch or declare intent to scratch pending another race.
- b. A swimmer who declares intent to scratch must declare their final intentions within 30 minutes following the announcement of the preliminary results for their last individual preliminary event of the session.
- c. After the scratch deadline, finals qualifiers will be posted with results.
- d. Failure to compete – This meet shall follow the WI Swimming scratch 4.1.3 Scratch Rule. If a swimmer qualifies for a final and does not scratch and fails to compete in the final, the swimmer shall be barred from further competition for the remainder of the meet. Disqualification under this section shall apply only to swimmers qualifying based on the original preliminary results.

Warm-up procedures will be in effect. Circle swimming only, except in designated lanes and times. Feet first entry from the starting end during general warm-ups and cool down periods will be enforced. Warmup assignments will be communicated to participating teams after entries are received. No snorkels, kickboards or other training devices are allowed during warmups. Swimmer(s) without a coach present are to report to the Meet Director prior to warmups for lane assignment.

Breaks may be added/adjusted, heats may be combined, and additional events may be positive check-in at the discretion of meet management.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. Further, those participants not proficient with a backstroke ledge must start each race from within the water, and without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**Deck Entries:** The entry fee for deck entries will be \$15.00 per individual event. Deck entries will be allowed at the discretion of the Meet Director if the timeline permits. Deck entries close 30 minutes prior to the start of the session. On-deck registration may be permitted with meet management approval.

**Coaches:** Coaches' Packets will be available in the office. Please be prepared to show your USA Swimming Coach's Card at the time of picking up your packet. Coaches must check in for each session and coach cards must be visible at all times on deck.

**Timing:** Each team with swimmers in the meet will be asked to provide timers. A list of lane assignments for each team will be posted at least 48 hours prior to the meet.

**Awards & Scoring:** Individual Events: Ribbons 1<sup>st</sup> – 10<sup>th</sup> place for ages 12 and under.  
Team: 1<sup>st</sup> Place Team High Point Award for 12&U and 13&O  
Scoring Individual Events: 24,21,20,19,18,17,16,15,14,13,11,9,8,7,6,5,4,3,2,1  
Scoring Relay Events: Double Points

**Heat Sheets:** Heat sheets will be available on our website and Meet Mobile.

**Concessions:** Food and beverages will be available on the premises. No food or beverages are allowed in the pool area. No glass is allowed

**Conduct:** All coaches are responsible for the conduct of their swimmers and will see that their club has proper supervision at all times. Meet Marshals shall have the authority to remove any swimmer/s from the meet for any violation such as improper behavior, damage to property, etc. Such teams are responsible financially for damage of property. Please make sure your team's area on deck and rest area is picked up at the end of each session.

Use of audio or visual recording devices, including cell phones, is not permitted in the changing areas, restrooms, or locker rooms. Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited. Deck changes are prohibited.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair.

**First Aid:** Injuries must be reported to the Lifeguard and to the Meet Director. A first aid kit will be located at the Lifeguard station.

**Lost & Found:** An area for lost and found will be located by the desk near the facility entrance. Items not picked up by meet end will be donated.

**Meet Results:** Results will be posted on the Wisconsin Swimming website and emailed to participating teams.
