



CERTIFICATE OF SURVEY:

I hereby certify only to the parties named hereon that we have surveyed and divided into four parcels, at the direction of said parties, a parcel of land previously described as:

TAX ID: 33-11-11-36-100-002 NW 1/4 OF NW 1/4 OF SEC 36, EXC THAT PART W OF DEXTER TRAIL SEC 36 T2NR1E

and that we have found or set, as noted hereon, permanent markers to all corners and angle points of the boundaries of said parcels and that the more particular legal descriptions of said parcels are as follows:

Parcel A

A parcel of land in the Northwest 1/4 of Section 36, T2N, R1E, Ingham Township, Ingham County, Michigan, the surveyed boundary of said parcel described as: Beginning at the Northwest corner of said Section 36; thence N89°48'01"E along the North line of said Section 36 a distance of 847.47 feet; thence S00°11'59"E perpendicular to said North line 232.51 feet; thence S89°48'01"W parallel with said North line 371.13 feet; thence S61°55'11"W 311.47 feet to the centerline of Dexter Trail; thence N37°35'11"W along said centerline 185.57 feet; thence continuing along said centerline Northwesterly 250.48 feet along a curve to the right with a radius of 436.30 feet, a delta angle of 3253'38", and a chord of 247.06 feet bearing N21°09'14"W to the point of beginning; said parcel containing 5.00 acres, more or less, including 0.32 acre, more or less, presently in use as public right-of-way for Dexter Trail; said parcel subject to all easements and restrictions, if any.

A parcel of land in the Northwest 1/4 of Section 36, T2N, R1E, Ingham Township, Ingham County, Michigan, the surveyed boundary of said parcel described as: Commencing at the Northwest corner of said Section 36; thence along the centerline of Dexter Trail Southeasterly 250.48 feet along a curve to the left with a radius of 436.30 feet, a delta angle of 32.53'38", and a chord of 247.06 feet bearing S21.09'14"E; thence S37.35'11"E continuing along said centerline 185.57 feet to the point of beginning of this description; thence N61°55'11"E 311.47 feet; thence N89°48'01"E parallel with the North line of said Section 36 a distance of 371.13 feet; thence N00°11′59″W perpendicular to said North line 232.51 feet to said North line; thence N89°48'01"E along said North line 483.77 feet to the East line of the West 1/2 of the Northwest 1/4 of said Section 36; thence S01°04'32"E along said East line 609.06 feet; thence S89°48'01"W parallel with said North line 719.00 feet; thence S66°52'04"W 200.32 feet to said centerline; thence N37°35'11"W along said centerline 388.74 feet to the point of beginning; said parcel containing 11.70 acres, more or less, including 0.29 acre, more or less, presently in use as public right-of-way or Dexter Trail; said parcel subject to all easements and restrictions, if any.

A parcel of land in the Northwest 1/4 of Section 36, T2N, R1E, Ingham Township, Ingham County, Michigan, the surveyed boundary of said parcel described as: Commencing at the Northwest corner of said Section 36; thence along the centerline of Dexter Trail Southeasterly 250.48 feet along a curve to the left with a radius of 436.30 feet, a delta angle of 32°53'38", and a chord of 247.06 feet bearing S21°09'14"E; thence S37°35'11"E continuing along said centerline 574.31 feet to the point of beginning of this description; thence N66°52'04"E 200.32 feet; thence N89°48'01"E parallel with the North line of said Section 36 a distance of 719.00 feet to the East line of the West 1/2 of the Northwest 1/4of said Section 36; thence S01°04'32"E along said East line 265.17 feet; thence S88°55'28"W perpendicular to said East line 755.83 feet to said centerline; thence N37°35'11"W along said centerline 250.00 feet to the point of beginning; said parcel containing 5.14 acres, more or less, including 0.19 acre, more or less, presently in use as public right—of—way for Dexter Trail; said parcel subject to all easements and restrictions, if any.

A parcel of land in the Northwest 1/4 of Section 36, T2N, R1E, Ingham Township, Ingham County, Michigan, the surveyed boundary of said parcel described as: Commencing at the Northwest corner of said Section 36; thence along the centerline of Dexter Trail Southeasterly 250.48 feet along a curve to the left with a radius of 436.30 feet, a delta angle of 32°53'38", and a chord of 247.06 feet bearing S21°09'14"E; thence S37°35'11"E continuing along said centerline 824.31 feet to the point of beginning of this description; thence N88°55'28"E perpendicular to the East line of the West 1/2 of the Northwest 1/4 of said Section 36 a distance of 755.83 feet to said East line; thence S01.04'32"E along said East line 444.48 feet to the South line of the North 1/2 of the Northwest 1/4 of said Section 36; thence S89'49'44"W along said South line 431.90 feet to said centerline; thence N37°35'11"W along said centerline 544.53 feet to the point of beginning; said parcel containing 6.00 acres, more or less, including 0.41 acre, more or less, presently in use as public right-of-way for Dexter Trail; said parcel subject to all easements and restrictions, if
