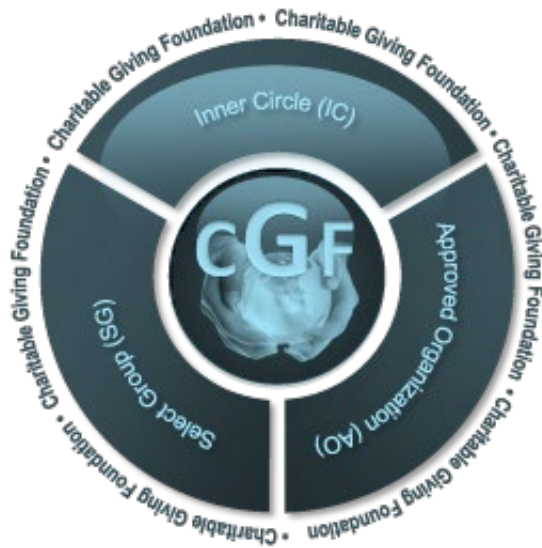

**John T. Carr- 72 years young- Irvine, CA:** John is a Senior Olympic and master's Track and field Athlete and encourages everyone, even at his age, to consider participating in this exciting and very rewarding activity. In 2008, John was tied for fourth (4th) in the USA and second (2nd) in California for the 100-meter Sprint in a record time of 13.3 seconds. The All-American Standard for this event is 13.8 seconds. In 2009, John placed eighth (8th) in the World, fifth (5th) in the USA, and first (1st) in California in the 80-meter High Hurdles; with a record time of 16.64 seconds. The All-American Standard for this event is 18 seconds. In 2010, at the age of 71; John placed eighth (8th) in the USA and eighth (8th) in California in the 80-meter High Hurdles again, in a time of 17.41 seconds. Again, the All-American standard for this event is still 18 seconds. John is also in the top ten (10 ) or fifteen (15) in the World, in the 200 and 400-meter runs and the ever-difficult 300-meter Hurdles.

National master's News published a beautiful article that he submitted. It was an article about one of John's close friends and Mentors he called `Coach`. He was a former track coach at both USC and

Stanford University and is considered one of the Greatest Senior athletes in the WORLD. John had dinner with him and held his hand for hours just a few days before he passed away of Cancer. That weekend John competed in a Track and Field meet in Palm Desert and dedicated ALL his medals to him and his memory. John competed in Five (5) different events and won medals in ALL five(5) events. We ALL agree that John is a True living example of what he promotes with his Wonderful Charitable Giving Foundation.
