TUITION AND FEE DESCRIPTIONS:

Annual Tuition: Tuition includes two semesters of instruction, textbook usage, yearbook, technology, participation in sports, graduation activities, and standardized testing. It includes the cost of event transportation and membership dues for the Association of Christian Schools International (ACSI) and Western Association of Schools and Colleges (WASC). The first tuition payment is due in the form of the \$2,500 Enrollment Deposit to reserve a seat in the class. Tuition is non-refundable and the remainder must be paid in full by June 20, unless a semester payment plan is requested. *Single Semester Tuition is \$12,250.* A 10% late fee will be charged to accounts not paid by June 20.

Application Fee: This fee is required to cover the cost of evaluating applications, filing records, and conducting interviews. This fee is non-refundable and must be paid at the time the application is submitted. **Students applying during the Early Admission Cycle receive a \$50 discount off the application fee.**

Homestay: San Francisco Christian School requires all students to live with an English-speaking adult who is at least 21 years of age. San Francisco Christian School will secure homestay arrangements for the entire school year, if needed. SFCS host families typically charge between \$14,000 to \$18,000. The charge for homestay is due by June 20, 2024 and is distributed to the host family on a monthly basis by the SFCS Finance Office. All homestay arrangements, including non-parental relatives, must be approved through SFCS prior to enrollment.

Medical Insurance: San Francisco Christian School requires all students to have medical insurance while in attendance. If a student has already purchased medical insurance through a school placement agency or U.S. relative, proof of coverage must be presented to SFCS by July 26, after which he or she will be automatically signed up for insurance and billed accordingly. Medical insurance purchased through the school will be effective until the end of the school year. A student remaining with a host family over summer break must notify the Admissions Office and will be charged for extended medical insurance coverage.

PAYMENT OPTIONS:

Credit Card: Pay with PayPal or credit/debit using the “Pay Here” button on the SF Christian School website. All credit card payments are subject to a 3.5% processing fee.
