OLD BUSINESS:

Scott Varney, the Village Fiscal Officer, asked if there was any need to discuss the Department of Commerce request by Sheetz from the prior meeting and schedule a meeting regarding the Liquor permits. If the Village is fine with them, there is no need for further action. Mr. Bartko asked if we knew what they were requesting. Mr. Varney said they were asking for a C2, D1, C1, and a D6. Mrs. Chetyrkina-Miller asked if that was for carry out of beer, wine, and mixed beverages seven (7) days a week, and the on-premise consumption of beer, wine, and liquor, but retail sales do not

include liquor? Mr. Varney stated that he agreed. The Mayor asked if on-premises could be an issue? Mrs. Chetyrkina-Miller suggested that this might be a question for Marshal Pitchford, the Village Solicitor. A discussion ensued with members of the audience as to the number of licenses a municipality might be limited to. Mr. Antal is going to discuss this issue with Marshal and give Mr. Varney an answer before the reply deadline of December 7th, 2025.

NEW BUSINESS:

Mayor Antal wanted to express his condolences to the Fenn family on the passing of Brian Fenn. He stated a tree was planted in the Village in Brian's name, and flowers were also sent. The Mayor also wanted to thank Officer Richard Hildreth for his years of service. He is leaving to go to another city, and also, Office Haley Orick is leaving and heading in a different direction. Breakfast with Santa is on Saturday, December 20th from 9:00 am until 11:00 am. It is posted on the website, and there is also a flyer. Juice, coffee, bagels, and muffins are typically served. 


