**OPEN FORUM 1:**

Mr. Richard Herbig asked a few questions about the new Safety Service Center. He received a newsletter and felt the diagram was so small that he wanted clarification on some images of the beds in the sleeping facilities of the fire station. He questioned the amount and was told the area was large enough to expand in the future if needed. Mr. Herbig questioned the police area sketch regarding the sally port and holding cells. Mr. Maccarone stated that a larger drawing of the schematics is available on the website and can be zoomed in on for a clearer view of the rooms. Further discussion on the Service Center ensued. The Mayor reiterated that everyone is invited to attend the special meetings on Fridays concerning the Center.

Dr. Michelle Blanda commented that she was an emergency physician, and she has been to numerous EMS stations. Extra beds for sleeping arrangements are very common. She continued with a two-person minimum on duty; this would be appropriate. Dr Blanda then addressed the tax abatement for Arhaus, specifically the 85% tax abatement over 15 years and the creation of 230 jobs, with 163 additional. She asked if the numbers could be shared of what really has occurred. Dr. Blanda also questioned the \$1.8 million dedicated from Arhaus for the bike trail she thought she had read in the newspaper, and did that ever happen? The Mayor stated he knows of no agreement to pay for any of the bike trail. Mr. Maccarone stated that Arhaus

represents about 800 jobs at the facility in the Village. Dr. Blanda also stated in light of the budget being put on the agenda and being published as a public meeting, there is a problem that not everybody can attend. She felt maybe the meeting could use streaming possibilities. The Mayor stated the Village is considering changing to fiber and getting quotes to make the meetings available to everyone.

**OLD BUSINESS:**

Chetyrkina-Miller had a question whether the fire department, being in a fire district, has engaged concerning the financing of the space, and whether will it be broken down into contributions for the township and for Peninsula to pay some of it, or if it has not been discussed yet. The organizational meeting will be held on Tuesday, January 6<sup>th</sup>, and all Council and finance meetings are listed in the schedule. Mr. Miller then asked what the Village's cash reserve situation is at this time. Mr. Varney stated there is about \$4.5 million in reserves in the general fund. The fund is there in case a catastrophic event happens.

Mr. Joe Blanda asked a follow-up question to the live streaming and when it might happen. Mayor Antal stated that maybe as soon as January.
