## **ADOPTION OF AGENDA:**

### **OPEN FORUM 1:**

Richard Herbig asked if the rules were set up for the pickleball courts starting with the fall festival. The Mayor stated benches were ordered, and a meeting the next day will confirm that the rules sign has been put up. Mr. Herbig also wanted to know about Brandywine Rd. dead trees. He said one has hit a power line and needs to be removed before someone gets hurt. The Mayor stated emails have been going back and forth all week about right-of-way issues. He said if the tree is in the right of way, it's the Village's responsibility to take care of. Brian Gorog, the Village Engineer, added that if it's on private property, there are no regulations actively in place to address this. In the future, the Village will investigate this issue, develop a policy, and communicate with residents about dead trees that need to be removed.

S. Chetyrkina-Miller wanted to explain why she voted no; she felt she received this Ordinance only a few hours before the meeting and did not have time to research the changes being made. Marshal Pitchford explained to Council that this is just the State updating the State Legislation and not the Village changing anything. This is something that happens every year to be consistent with State Law.

The Mayor then asked S. Chetyrkina-Miller if she now wanted to take another vote on the Ordinance, and she stated yes.

# **OLD BUSINESS:**

Brian Gorog, Village Engineer, explained the Summit County letter that was sent to residents on Wolcott Rd. He had a phone conversation with Julie Reis, who is a Water Quality Manager for Summit County Public Health, and she said it was a formality from the Ohio Revised Code that they have to go through. Residents just need to call them and explain individual circumstances and follow up with an email as to extensions or financial needs. She explained every case is different and the Village has no control over any of it. Brian went on to explain DSSS, who is responsible for overseeing the construction of systems, verbally told the Village residents that they would not have to tie in, but when pushed, would not put it in writing. The letter is from the Summit County Health Dept., and they control the enforcement on this. They are in control of the septic systems and connections to the sanitary sewer. Mr. Maccarone stated he does not feel comfortable telling residents to call the Health Dept. when they come to him for answers.
