

### **BZA 5-7-25**

The Board of Zoning Appeals (BZA) meeting on May 7, 2025, reviewed an application from Jeffrey and Nancy Cross for a variance of fencing height and location at 6651 Old Eight Road, Boston Heights, Ohio. The Crosses sought a variance to install a 7.5-foot high, no-dig, high-tension, double-dipped galvanized steel fence with a durable PVC coating to protect their garden from deer. The fence, recommended by the USDA for deer containment, is 321 feet from the road and 55 feet wide by 120 feet deep. The BZA unanimously approved the variances, noting the practical difficulty of maintaining the garden without the higher fence and the minimal impact on the neighborhood.

### **Call to Order and Initial Introductions**

- Bill Hinkle calls the meeting of the Board of Zoning Appeals to order at 7 PM.
- Members present include Mr. D. Maccarone, Ms. May, Mr. Fenn, and Mr. Wells.
- Bill Hinkle notes the absence of minutes and skips over that part of the agenda.
- The meeting is to review an application from Jeffrey and Nancy Cross for a variance of fencing height and location at 6651 Old Eight Road, Boston Heights, Ohio.

• The fence material is described as high-tension, double-dipped galvanized steel covered in a durable PVC coating.

- The board discusses the feasibility of the garden in the backyard and the need for a higher fence due to deer issues.
- A motion is made and seconded to grant the variances, with all members voting in favor.
- The board advises the applicants to ensure the contractor is registered with the village and provides additional information for the permit process.

- The applicants express their gratitude for the board's support and the thorough application process.
