## AN ORDINANCE ESTABLISHING COMMUNITY ENGAGEMENT AND TRANSPARENCY COMMISSION.

WHEREAS, the Village Council desires to increase knowledge, share more information, and increase the feedback loop between government and residents; and

WHEREAS, citizen interaction and two-way involvement are positive, effective means of improving government efficiency and openness; and

WHEREAS, citizen involvement in public decision-making processes fosters a culture of open government, increases public trust, and ensures accountability by providing access to information, facilitating meaningful public participation, and making government services more responsive to community needs.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of Boston Heights, Summit County, State of Ohio, as follows:

- <u>Section 1</u>. The Village of Boston Heights' Community Engagement and Transparency Commission is hereby established. The Commission is empowered to conduct research, draft legislation, and make recommendations to the Council for actions and expenditures.
- Section 2. The Commission shall have at least three members, including a minimum of one Council member and two volunteer residents of the village. Each member shall be appointed by Village Council. The Commission shall elect its own Chair and may adopt its own parliamentary procedures and/or rules.
- <u>Section 3</u>. The Commission's first responsibility is to develop and implement policies and guidelines for sharing Village-related information and promotions via electronic channels, including Facebook, the Village website, the Village app, text messages, and any future initiatives.
- <u>Section 4.</u> The Commission's second responsibility is to develop and implement policies and guidelines for printed communications, including a community newsletter and any future related initiatives.
- <u>Section 5</u>. The Commission's third responsibility is to develop and implement live streaming of public meetings, improve the efficiency and effectiveness of sharing Village Council and other boards and commission meeting agendas and meetings and any future related initiatives.
  - **Section 6.** The Commission shall exist until November 20, 2027.
