WHEREAS, at the time of his passing, Dave was a valued employee of the Boston Heights Road Department, where he served with the same unwavering work ethic, humility, humor, and dedication that defined every aspect of his life; and

WHEREAS, beyond his professional contributions, Dave was a devoted husband to his beloved wife Connie of 48 years, a loving father to seven children, and a foster parent to many others, opening his home and heart to those in need; and

WHEREAS, Dave leaves behind a lasting legacy through his family, countless acts of service and generosity, and the many lives he touched across Boston Heights and throughout the greater community.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Boston Heights, Summit County, Ohio as follows:

Section 1. That the Village formally recognizes and honors the extraordinary life, character, and service of David Alan Morehouse, and expresses profound gratitude for his many contributions to this community.

Section 2. That the deepest sympathies of the Mayor, Council, and residents of Boston Heights are hereby extended to his wife Connie, his children, grandchildren, extended family, friends, colleagues, and all who mourn his loss.
