A RESOLUTION AUTHORIZING THE VILLAGE TO ENTER INTO A PURCHASE AGREEMENT FOR A LEAF VAC.

WHEREAS, the accumulation of seasonal leaf debris on public streets and rights-of-way creates safety hazards, contributes to clogged stormwater systems, and increases the risk of localized flooding; and; and

WHEREAS, the Public Works Department currently relies on aging and less efficient equipment that results in increased maintenance costs, reduced operational efficiency, and delays in leaf collection services; and

WHEREAS, the Village administration recommends the purchase of a new leaf vacuum through Sourcewell Contract #112624-ODB, an authorized State of Ohio Cooperative Purchasing Program, which entity employs competitive bidding processes for equipment, satisfying the requirements for competitive bidding under the Ohio Revised Code and Village law; and

WHEREAS, the acquisition of a modern leaf vacuum truck will improve the efficiency and effectiveness of municipal leaf collection, reduce long-term operational costs, and enhance public safety and environmental compliance and is, therefore, in the best interest of the Village and its residents.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Boston Heights, Summit County, Ohio as follows:

Section 1. The Mayor and his designee are hereby authorized to enter into a purchase and installation contract with Best Equipment Company, Inc. for the purchase of a leaf vac, not to exceed the amount of \$175,000.

Section 2. The Mayor and Fiscal Officer are hereby authorized to spend up to \$175,000 budget authorization for said equipment.

Section 3. That the above recitals are fully incorporated as findings herein.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 5. This Resolution shall take effect and be in force from and after the earliest period allowed by law.


