

Civil/Commercial Online Mediation Training

This programme provides delegates with a minimum of 40 hours training to become a Civil/Commercial Mediator. The programme is taught by global experts that have decades of experience. Completion of the programme results in full accreditation as a Civil/Commercial Mediator meeting international standards in mediation.

Successful completion of this programme will allow you to gain the status of 'ADR ODR International Accredited Civil/Commercial Mediator'. Our course is recognised by Civil Mediation Council (CMC) in the UK; it is internationally recognised and certified by International Mediation Institute (IMI) and accredited by the Singapore International Mediation Institute (SIMI). This gives your qualification an internationally recognised kite mark of excellence, which means that our graduates obtain a prestigious qualification and have greater opportunities to begin their mediation practice in multiple jurisdictions across the world.

In 2019 we have invested in two Moodle platforms (e-learning platforms) so that our delegates can get a seamless hybrid learning experience. These e-learning platforms reflect the same design and accessibility that modern universities and centres of higher learning. In 2020 our dedicated team of experts have devoted a great deal of thought and time to develop additional resources and tools and have tested the technology to ensure that our online offerings are of the same quality as the in-person trainings that we offer.

Unlike general teaching online, which can be 1 hour to 3 hours, ADR ODR International courses are normally 6 days and 6-8 hours per day. Our International Faculty will be present online on 1:9 trainee to students ratio.

Our live video training takes place on Zoom. We provide each of our excellent trainers with a Zoom pro account, which allows them to create breakout rooms that they supervise by the same ratio of trainer to students. In addition, we have added extra reading and video content to the elearning platforms to support your learning.

In addition to the synchronous-asynchronous teaching, role-play and feedback times, we also allow a space for break times, so delegates can continue to have private time to get to know each other over a virtual coffee. We have held a number of these courses, with delegates from over 15 countries over 8 time zones and the feedback has been extremely positive.





Assessments



Assessments

The Civil/Commercial Hybrid Mediation Programme is assessed via a 90-minute role-play. This will be recorded by each delegate on their iPad or Laptop and sent to an independent assessor.

Certificate

Upon successful completion of the course once your results have been released, the e-learning platform will automatically generate a copy of your digital certificate for you.

Please note that the initial certificate will only include the SIMI accreditation/ logo on it due to the reasons explained in the paragraph below (this only applies to the online course).

Important to Note

Although, SIMI happily recognise and accredited our online courses, the CMC and IMI require that delegates top-up the online training with an in-person one assessment day.

These sessions are available in the countries where we currently operate and are included in the course fee.

Once you complete the top-up in-person assessment day your e-certificate will be eligible for an upgrade with the CMC and IMI logos.

If you complete the hybrid training, you do not have to complete an extra in-person assessment day.

CMC Accreditation

Once you have completed the full Civil/Commercial Mediation Training and the one day top-up Master Class in-person (if you completed the online training), you will have the option to apply for the CMC membership as an individual who is a panel member of a registered mediation provider.

Please note that in order to become a member of CMC's panel a separate annual fee for the same applies, which has to be paid directly to CMC.

SIMI Accreditation

ADR ODR International Civil/Commercial Mediation Course is a SIMI registered training programme (RTP). Thus, following your successful completion of the full Civil/Commercial Online Mediation Training you are automatically eligible to become SIMI Level 1 Accredited Mediator.

Please note that the automatic status is only applicable for 2 years from the date of completion of your course and in order to claim the status you are required to email our team at info@adrodrinternational.com with your interest to do the same upon which the team will check whether you are still within the 2 year period and if so, we will forward your application to SIMI for further approval. Once your application is approved you will be asked to join SIMI's panel membership and pay the fee of the same to them directly before appearing as SIMI Level 1 Accredited Mediator on their website.
