GENERAL PRICE LIST

Note: These prices are effective May 12, 2023, but are subject to change without notice.

The goods and services listed below are those we can provide to our families. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Direct Cremation (Includes Cardboard Alternative Container) \$695.00

Direct Cremation is the disposition of the body by cremation, without the added cost of embalming and formal viewing. This service is without any attendant, rites or ceremonies and includes the basic professional services of the funeral director and administrative staff for filing and obtaining legal documents and permits; removal of the deceased and transportation from the place of death to crematory (within a 30-mile radius); refrigeration, cremation process, alternative container, cremated remains returned in a temporary cardboard container, one Certified Death Certificate and the Medical Examiner Authorization fee. This service does not include embalming of the deceased; cosmetizing and hair care; viewing; merchandise selected such as cremation urn, register books or any other item which may be found on the General Price List. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials such as, fiberboard or composition materials (with or without an outside covering.) The containers we provide are cardboard.

Basic professional services of funeral director and staff \$395.00

This fee is for our basic services and overhead to be added to the total cost of the funeral arrangements you select. It includes, but is not limited to, availability of staff 24 hours a day, shelter of the deceased, consultation with the family or responsible party to determine the services desired and coordinating service plans with cemetery and/or other parties involved in the final disposition of the deceased. Also included in this charge are clerical and administrative services, filing of local death certificate with County Health Department, preparation and filing of necessary permits and a proportionate share of the taxes, licenses, utilities and business expenses necessary to serve the public in a professional manner. (This fee is already included in our charges for direct cremation.)

SERVICES:

Please note that embalming is not required for direct cremation and our establishment does not provide embalming or funeral services of any kind or immediate burials. It is our policy to require refrigeration of a non-embalmed body.

Veteran	\$1,095	Includes all of the basic package and two (2) additional Death Certificates totaling three (3); one (1) choice of three (3) selected urns or two (2) pieces of selected jewelry, and 48 laminated prayer cards or memorial folders
Eco-Friendly	\$1,195	Includes all of the basic package and your choice of biodegradable Eco Sphere urn and (1) additional death certificate Death Certificates totaling two (2)
Memorial	\$1,295	Includes all of the veteran package plus one (1) choice of three (3) selected urns and two (2) pieces of selected jewelry, and 48 laminated prayer cards or memorial folders

Payment Options

At Cremations America Central Florida, it is our goal to assist every family during their most difficult time. As we do not offer At Need payment installment plans, we have a range of other payment options to meet your needs. Please choose from the selection below which payment option works best for your needs. This will specify the method you have selected to pay for goods and services listed on the statement of goods and services selected.

- _____ **Option 1:** Payment in full amount by cash or check on the day of the arrangement conference.
- _____ **Option 2:** Payment in full by major credit card at time of arrangements. We accept Mastercard, Visa, Discover, and American Express.
- _____ **Option 3:** Life Insurance Assignment: Most insurance companies allow the beneficiary of the policy to assign payment for cremation services from the proceeds of the policy. For your convenience, we accept insurance assignments on policies that are two years or more. The insurance handling/assignment fee is \$300 in addition to the total of the statement of goods and services. All insurance assignments will be verified by Cremations America Central Florida.

If the insurance benefits are not assignable, has lapsed, or invalid, Options 1 or 2 will be necessary.

If the amount of the insurance benefits are less than the expenses, Options 1 or 2 will be necessary to satisfy the balance.

If the family chooses to collect the insurance themselves, that is not an insurance assignment and family will have to choose Options 1 or 2 as method of payment.

Estates:

Due to the complexity of Estates and the time involved, we do not accept this type of method of payment. The responsible family member will need to pay for the expenses and file a claim for reimbursement with the decedent's estate.
