#### **Statement:**

The most significant issue facing ACNL is continued membership growth in order to: strengthen the collective voice, sustain the organization, and have enough funding for program development that supports California Nurse Leaders. In these unprecedented times, uniting as a common voice in advocacy for nurse leaders, the profession of nursing, and the health and well-being of humanity are essential.
