Legal Fee Offerings

PRACTICE AREAS

Fees do not include court fees or other costs.

BANKRUPTCY

- Chapter 128: \$850-\$1,250 average (*Wisconsin Repayment Plan*)
- Chapter 7: \$1,950-\$3,250, filing fee \$338
- Chapter 13: \$4,500 starts at (Deposit and filing fee of \$313 to start)
- Means Test Analysis & Evaluation/Options: \$300-\$500 (applied towards Ch. 7 or 13 bankruptcy cost)

DIVORCE & LEGAL SEPARATION

- Limited Scope Assistance: \$1,550 / \$1,750 w/children; forms assistance through completion
- Mediation: \$3,950 - \$6,750 includes forms, unlimited mediation sessions, property charts, etc.
- Collaborative - hourly with retainer/deposit (\$3-5,000), see website for more info
- Traditional Divorce – hourly retainer/deposit (\$3-5,000) or level monthly fee (\$850 - \$1,550/mo)

FAMILY OTHER

- Paternity/Post-Divorce: level monthly fee (\$850-\$1,550) or hourly with retainer/deposit (\$3-5,000)
- Marital Agreements (Pre/Post-Nup): starting at \$1,550, plus hourly fee for negotiations after draft
- QDRO's (divide 401k's, pensions, etc.): \$400 (our processing fee), plus outside drafting fee (\$400-\$650)

ESTATE PLANNING - WILLS, TRUSTS, PROBATE, POWER OF ATTORNEYS

- Simple Will Package: \$750, includes Power of Attorneys for Health Care & Finances
- Couples Will Package: \$1,100, includes Power of Attorneys for Health Care & Finances
- Children's Trust with any Will Package, \$500 – allows all funds to be managed after death
- Revocable Living Trust: \$2,250 Single; \$3,550 Couple; *Includes Will Package, transfers separate*
- Probate: hourly with retainer deposit (\$3,000 average), or flat fee option in some cases

REAL ESTATE - Appraisals, Title Policy, and recording fees separate (**\$30 per recording**)

- Deeds \$300, including Quit Claim Deed, Termination of Decedent or Transfer on Death Deed
- Buyer/Seller - Residential Package through closing \$1,550; *Offer to Purchase Only*: \$750

CIVIL & OTHER – Hourly or Flat fees quoted on case by case basis

- Foreclosure Defense - level monthly fee throughout representation
- Cohabiting / Partition Action for real estate - hourly with retainer/deposit (\$3-5,000)
- Fair Debt Collection Practices claim against creditor
- LLC Start-up: \$400 (consult, state/federal forms, single member operating agreement)

Fee Options

- Coaching/Consulting/Limited Scope/Unbundled: hourly - paid at time of service, or on-going with deposit
- Flat Fees - offered in some cases, does *not* include trial or trial prep (separate fee required)
- Hourly rates: \$250 - \$500 with retainer deposit & guarantee (required)
- Level Monthly Fee option – paid monthly until case is concluded (keeps billing consistent)
