#### Our fee for the basic services of the funeral director and staff includes but is not limited to:

- Responding to the initial request for service
- Conducting the arrangement conference
- · Preparation of biological and statistical data
- Examination of financial settlement options
- Coordination with those providing other services
- Preparation and placement of obituary notices
- Retention and care of remains prior to the commencement of post-death activities

This fee for our basic services will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial. If you choose to have an embalming performed, the decedent may be embalmed at a location other than this registered mortuary. N.J.A.C 13:36-9.7 (d)(2) No human remains may remain unburied or uncremated in the State of New Jersey for a period longer than 48 hours unless embalmed by arterial and cavity injection or kept refrigerated at 45 degrees Fahrenheit. N.J.A.C. 8:9-1.1

#### FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME

\$2.350.00

This package charge includes removal of remains to this registered mortuary, basic services of funeral director and staff, the basic sheltering of remains, embalming, and obtaining the necessary permits. This charge does not include a casket or alternative shipping container, the use of facilities and staff for any visitation or ceremony, public or private, prior to forwarding the remains, or the sheltering for days on which no post death activities occur. Nor does it include transferring the remains to the airport or other destination, or the charges of a common carrier, or anything not expressly stated as being provided.

# RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME

\$2,995.00

This package charge includes receiving the remains from another funeral home, basic services of funeral director and staff, the basic sheltering of remains, obtaining the necessary permits and authorizations, and local (within 30 miles) transportation to the cemetery or crematory. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial or cremation, or any sheltering for days on which post death activities occur. Nor does it include transferring the remains from the airport of other source, the charges of a common carrier, or anything not expressly stated as being provided.

#### IMMEDIATE BURIAL

from \$3,195.00

This package charge includes the basic services of the funeral director and staff, local (within 30 miles) transfer of remains to the funeral home, basic sheltering of remains, obtaining the necessary permits and authorizations, local transportation to the cemetery, sanitary care and preparation of remains for identification, and alternative container. It does not include use of facilities and staff for any visitation or ceremony, public or private, prior to burial or any sheltering for days on which no post death activities occur. Nor does it include the actual cost of the grave at the cemetery, the cemetery's charges for opening and closing the grave, any required outer burial container or cash disbursements, or anything not expressly stated as being provided.

Immediate burial with a casket selected from our funeral home \$3,195.00 (plus cost of casket)

Immediate burial with casket proved by purchase \$2,595.00

#### **DIRECT CREMATION**

from \$2.395.00

This package charge includes the basic services of the funeral director and staff, local (within 30 miles) transfer of remains to the funeral home (does not include additional assistance charge for transfer from a residence), basic sheltering and refrigeration of the remains, obtaining the necessary permits and authorizations, local transportation to the crematory, sanitary care and preparation of remains for identification. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to cremation, or any sheltering for days on which no post death activities occur. Nor does it include the actual cost of the cremation process, which is a crematory charge, or any other cash disbursement, or anything not expressly stated as being provided. If you want to arrange a direct cremation, you can use an alternative container.

Alternative containers encase the body and can be made of materials like fiberboard or composition materials, with or without an outside covering. \$2,400.00

When an alternative container is required by the crematory an additional \$195.00 will be added. See casket price list for charge details.
