PLAYER & PARENT PARTICIPATION AGREEMENT

PLAYER AGREEMENT

I, _____, have been selected and have accepted a position on a team within the Wilson Youth Soccer Association. As a member of the Wilson Youth Soccer Association, I agree to adhere to the following code of conduct:

- I will respect my teammates, coaches, the WYSA staff, and the opposing team and its players and will not engage in any disrespectful conduct.
- I will respect the referees and will not challenge or show dissent with officiating decisions.
- I will not engage in any activity that encourages unsporting behavior.

If I violate the above code of conduct, I understand that the following guidelines are used to establish the maximum punishment that can be levied by WYSA:

- Disrespect of coach, teammate, or opposing player – 1 Match Suspension
- Ejection from a match (*first offense) – 1 Match Suspension
- Ejection from a match (*second offense) – 1 Season Suspension
- Ejection from a match (*third offense) – Lifetime Suspension from WYSA
- Verbal assault/hostile challenge of a referee/coach/player – 1 Year Suspension
- Physical assault of referee/coach/player – Lifetime Suspension from WYSA

The WYSA, in its discretion, may hold a hearing to determine punishment different from the above guidelines. Further, I understand that the above guidelines do not exclude discipline by the North Carolina Youth Soccer Association (NCYSA). I understand that the Rules established by the NCYSA apply and supersede the Rules and any punishment for inappropriate play and behavior established by WYSA.

By signing this form, I acknowledge that I have read the Rules of WYSA. I agree to abide by those Rules including any fines and penalties.

- Offenses are tracked over a 1 seasonal year period (June-May)
- Unserved NCYSA suspensions or discipline carry forward

PARENT AGREEMENT

I/We, _____, the parent/guardian(s) of _____, agree to the following code of conduct:

- I/We will respect the opposing team and its players and will not engage in any disrespectful conduct.
- I/We will respect the referees and will not challenge or show dissent with their officiating decisions.
- I/We will not shout instructions to or attempt to “coach” my child during practices and/or matches.
- I/We will not engage in any activity that encourages unsportsmanlike behavior by my child.
- I/We recognize and respect that the coach will use his/her experience and ability to best develop each player and that sometimes player and team development will be given greater priority than winning.
- I/We will respect the methods and decisions of the coach and the club staff to provide a proper and appropriate training and match environment for my child.
- I/We will fulfill my financial commitments to WYSA in the timeline outlined by the club.
- I/We will commit to having our child present at all training sessions and matches.
- I/We understand that the commitment to the WYSA is for a seasonal year from June-May.

If I violate the above code of conduct, I understand that the following guidelines are used to establish the maximum punishment that can be levied by WYSA:

- Disrespect, Ejections from a match, and any verbal or physical assault of a referee/coach/player will result in the same punishment described in the player agreement.
 - If a parent is ejected from a match, the parent must leave the facility (out of sight and sound of the field) immediately.
- Failure to meet financial commitments:
 - WYSA reserves the right to revoke the player pass of a player who has neglected financial obligations to WYSA or the individual team. Players may not participate in training or matches until such issues are resolved.
 - Players who leave team (i.e. quit) prior to the end of a seasonal year maintain the obligation to pay any remaining WYSA and/or team fees. Approval from the WYSA Board of Directors is required to override this requirement.
 - Any outstanding debt to WYSA or an individual team must be resolved prior to being carded for a WYSA team in the future.
 - Any discrepancies will be resolved by the Board of Directors and the Director of Soccer.
