



SUMMER 2026 – ACADEMY HANDBOOK ADDENDUM

The policies below supersede those outlined in the *2025–2026 Academy Handbook*. All families are required to review the handbook in its entirety, as it contains important information regarding dress code, arrival and departure procedures, lobby expectations, and additional studio guidelines.

Enrollment Timeline

- **Priority Enrollment:** Now – March 31, 2026
 - **Open Enrollment:** Begins April 1, 2026
 - **Registration Fees Waived (Current Students):** Now through April 15, 2026

Registration Fees & Tuition Due Dates

(Please refer to the Summer 2026 Brochure for full tuition rates and class schedules.)

Summer Intensive Program (SIP)

- Registration Fee: \$50
- 1/6 of total tuition due at enrollment
- 1st Installment (1/3 of tuition): Due June 1, 2026
- Final Installment (remaining 50%): Due July 1, 2026

Kids Dance Camp

- No registration fee
- \$50 non-refundable deposit due at enrollment
- Remaining balance due June 1, 2026

Weekly Classes (Children & Adults)

- Registration Fee: \$15
- 1/3 of tuition due at enrollment
- Remaining balance due June 1, 2026

*Custom Maintenance Programs

- Registration Fee: \$15
- 1/3 of tuition due at enrollment
- Remaining balance due June 1, 2026

**Custom Maintenance Programs are available to dancers in Level 1B and above who choose not to participate in the Summer Intensive Program. Enrollment must be completed in person.*

Enrollment, Commitment & Withdrawal Policy

- Enrollment secures a dancer's place in class; withdrawals are not permitted once the program starts.
 - Tuition is non-refundable. Families remain responsible for the full balance regardless of attendance.
 - **No credits or refunds** will be issued for missed classes or for dropping classes prior to the start of any of the above programs/sessions.

Discounts

- **10% Family Discount:** Families with 2+ children enrolled in the same program or workshop
 - **10% Pay-in-Full Discount:** For cash/check payments made in full by at the time of enrollment
 - **Registration Fee Waiver:** Available to current students who enroll by April 15, 2026

Attendance & Makeup Classes

- Makeup classes are available for dancers in Children's and Adult Weekly Programs (subject to availability)
 - Summer Intensive Programs are not structured to allow makeup classes

End-of-Summer Student Showcase (SIP)

- Students enrolled in the full SIP will participate in the End-of-Summer Student Showcase
- Students attending weekly SIP sessions may be considered on a case-by-case basis, depending on the total weeks enrolled and other factors
- Students taking only maintenance classes are not eligible if they are in Level 1C and above.
- Costume costs are to be determined and will not exceed \$60.
