Scholarship Fund for LCBC

Approved in Church Conference October 9, 1994

Article I Name

The Name of this fund shall be the Harold W. Mills Scholarship Fund.

Article II Purpose

The purpose of the Harold W. Mills Scholarship Fund shall be to aid graduating high school seniors to further their secondary education in order to better equip them to serve our Lord Jesus Christ.

Article III History

The Harold W. Mills Scholarship Fund was begun in 1994 by a gift of \$50,000.00 from Jennie Mills in memory of her husband, Harold W. Mills. In establishing the scholarship fund the Mills family expressed their desire to assist the young people of Little Cypress Baptist Church in furthering their education.

Article IV Administration

- 1. The administration of the fund will be the responsibility of the scholarship fund trustees, which will be the church treasurer and two other church members selected by the church staff and approved by the church.
- 2. The available monies to be used for scholarship purposes shall be limited to the interest gained from the scholarship fund.
- 3. The investment of the monies shall be the responsibility of the scholarship fund trustees. The investments and their performance shall be reported to the church at regular scheduled church conferences.

Article V Applicant Qualifications

- 1. Applicants shall be only those who are active members of Little Cypress Baptist Church of Orange, Texas.
- 2. Consideration shall be given in the following order:
 - a. Students who have completed high school and plan on entering a college, university, or vocational school.
 - b. Students who are already enrolled in and are continuing their education in a college, university, or vocational school.
 - c. Students entering or continuing in graduate or seminary studies.
- 3. The grade point average of the student will be considered by the scholarship fund trustees.
- 4. The applicant must submit a written application four months prior to anticipated entry into school.
- 5. Applicants who have already received money from the scholarship fund must reapply annually.
