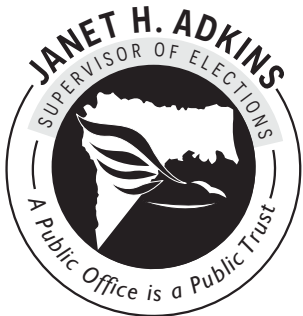

November 4, 2026 9:30 AM	Scan ballots into Independent Audit System.
November 5, 2026	9:30 AM - Scan ballots into Independent Audit System. 4:00 PM - Canvass provisional ballots & vote by mail cures. Certify first unofficial election results. [F.S. 101.048, 101.68(4)(b), 102.141(5)]
November 6, 2026 9:30 AM	Pre-sort ballots to prepare for recount ordered. (If needed.) Adjudicate unreadable cards in the Independent Audit System. [F.S. 102.141(7)(c), FAC R1S-5.026]
November 9, 2026 9:30 AM (If needed)	Pre-sort ballots to prepare for recount ordered. (If needed.) Adjudicate unreadable cards in the Independent Audit System. [F.S. 102.141(7)(c), FAC R1S-5.026]
November 10, 2026 9:00 AM (If needed)	Conduct machine recount ordered and certify second unofficial results. Conduct manual recount (If needed)(F.S. 102.141, 102.166, FAC Rule 1S-2.031)
November 13, 2026 4:00 PM	Process 10-day overseas ballots; Certify official election results. [F.S. 101.6952, 102.112, FAC Rule 1S-2.030]
November 16, 2026 2:00 PM	Perform post- election audit of voting system. [FAC Rule R1S -5.026]

The Nassau County Canvassing Board may convene at other times as deemed necessary. For schedule updates, please visit www.VoteNassauFL.gov/Notices. Refer to each meeting agenda for specific activities. The Nassau County Supervisor of Elections will use Clear Audit, if available, to facilitate post-election audits and any required recounts. Election staff will scan ballots into the recount/audit tabulation system in advance of the audit and any potential recounts.

Anyone who casts a provisional ballot has two days after the election to provide proof of eligibility to the Canvassing Board. The deadline for this election is November 5, 2026, at 5 PM. [F.S. 101.048]

NOTE: Persons are advised that if they wish to appeal any decision made at these meetings, they will need a record of the proceedings, and for such purpose they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based, per Section 286.0105, Florida Statutes.
