Refer to each meeting agenda for specific activities. The Nassau County Supervisor of Elections will use Clear Audit, if available, to facilitate post-election audits and any required recounts. Election staff will scan ballots into the recount/audit tabulation system in advance of the audit and any potential recounts, as shown, below.

August 22, 2026 (If needed)	9 am	Conduct machine recount ordered and certify second unofficial results. Conduct manual recount (If needed) (F.S. 102.141, FAC Rule 15-2.031) [F.S. 102.141(7)(c), 102.166, 102.112]
August 24, 2026	2 pm	Perform post-election audit of voting system. Certify official election results. [F.S. 102.141(10)(a), FAC Rule 15-5.026]

Anyone who casts a provisional ballot has two days after the election to provide proof of eligibility to the Canvassing Board. The deadline for this election is August 20, 2026, at 5 pm. [F.S. 101.048]

NOTE: Persons are advised that if they wish to appeal any decision made at these meetings, they will need a record of the proceedings, and for such purpose they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based, per Section 286.0105, Florida Statutes.
