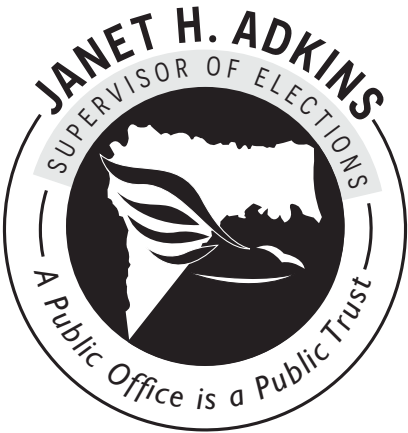

Citizen Initiative Ordinance Requiring Voter Approval for Paid Parking in the City of Fernandina Beach
The City of Fernandina Beach shall not implement paid parking in any designated area, defined as all areas within the City, without majority approval (50% plus one) vote from a public referendum of registered City voters. This ordinance does not prohibit the City from implementing temporary parking measures during special events. Such measures require public notice at such time a special permit is issued and not last longer than 30 days.

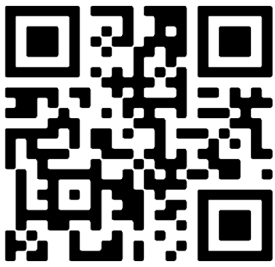
