Terms and Conditions

micro-pelle.fr is the trading name of SPARK-IN SAS, a company with a share capital of €37,500, whose registered office is located at 7, rue Paul Cézanne, 10120 SAINT GERMAIN, France. Registered with the TROYES Trade and Companies Register under number 487512824 RCS TROYES. The website is the sole property of SPARK-IN, as are all rights pertaining thereto. Any reproduction, in whole or in part, is prohibited without the prior written consent of SPARK-IN.

Article 1 - APPLICATION OF THE TERMS AND CONDITIONS

The seller is defined below as SPARK-IN. The buyer is defined below as the person signing and accepting these terms and conditions of sale. These general terms and conditions of sale apply exclusively to all sales concluded via SPARK-IN. Any other terms and conditions shall only be binding on the seller upon written confirmation from the seller. The information provided in catalogues, price lists, on the website, in notes, etc. is provided for information purposes only and may, as such, be modified by the seller without prior notice. The specifications of the products presented on the website are subject to change. The photographs, graphics, text and information relating to each model are not contractually binding. As such, SPARK-IN cannot be held liable in the event of any error or omission in the presentation or in the event of any modification to a product's specifications by the supplier. The mere act of placing an order or accepting an offer from the seller constitutes unreserved acceptance of these general terms and conditions. The terms and conditions may be amended at any time and without notice by SPARK-IN, with such amendments then applying to all subsequent orders. The geographical area covered by the SPARK-IN offer is Europe.

Article 2 - PRICES

The prices shown on the website are in euros, excluding VAT and delivery charges. The total price stated in the order confirmation is the final price in Euros, inclusive of all taxes. It includes the price of the items, packaging costs and delivery charges. The total price of the order is payable in full, in Euros only, on the day the order is confirmed. SPARK-IN reserves the right to amend the prices of items on the website at any time without prior notice.

Article 3 - ORDERS

To place an order, the buyer must first register. To do so, they must complete a form provided online, following the instructions given, and provide the information required for identification, including their surname, first name, telephone number, postal address, email address, billing address and delivery address. Further information may be requested at a later stage to ensure the quality and security of the delivery. Orders become effective from the date of receipt of payment for cheques or bank transfers and from the date the buyer's account is debited for credit cards.

Article 4 - PAYMENT

Payments must be made in such a way that the seller has access to the funds on the due date. Payments may be made by bank transfer, credit card or cheque at the time of ordering. Cheques are cashed upon receipt. No cash-on-delivery shipments will be made. Any payment made to SPARK-IN shall not be considered a deposit. The buyer may never, on the grounds of a complaint made by them, withhold all or part of the sums owed by them, nor may they set off any amounts. Where the buyer is in arrears with payment, in whole or in part, of an instalment by its due date, the seller may, on that ground alone and without the need for prior formal notice, immediately suspend deliveries without the buyer being entitled to claim damages from the seller. In the event of legal proceedings, the seller is entitled to claim from the buyer reimbursement of all costs associated with the proceedings. For any payment made via the website, the seller reserves the right, prior to accepting the sale, to ask the buyer to provide proof of their identity and place of residence.

Payment by cheque upon ordering: The cheque must be sent, dated, signed and made payable to SPARK-IN to the following address (please specify):

. The buyer must also write the order number on the back of the cheque. Once the order has been registered, the buyer has 10 days, including delivery time, to send us the cheque for payment. After this period, the order will be automatically cancelled.

NB: Cheques are cashed upon receipt. A bank cheque may be requested if the amount exceeds €300. SPARK-IN accepts cheques denominated in euros only and drawn on a bank with a branch located exclusively within France.

Payment by bank transfer at the time of ordering. To do so, please contact us to obtain our SEPA details.

The buyer must also specify the relevant order number in the transfer instructions. Once the order has been registered, the buyer has 10 days to make the transfer. After this period, the order will be automatically cancelled.

Article 5 EN_DASH DELIVERY

Delivery times are always given as an indication only, including on the quotation. Consequently, exceeding delivery times shall under no circumstances give rise to the payment of damages, deductions or the cancellation of orders in progress. By express agreement, force majeure or events such as lockouts, strikes, total or partial work stoppages at the seller's factory or at its suppliers' premises, epidemics, war, requisitioning, fire, flooding, disruption or delay in transport, or legal or administrative measures preventing, restricting, delaying or prohibiting the manufacture or import of the goods, the seller shall be released from all liability regarding delivery. SPARK-IN will keep the buyer informed, in a timely manner, of the cases and events listed above. In all cases, delivery within the agreed timeframe can only take place if the buyer is up to date with their obligations to SPARK-IN. Delivery of the equipment never includes commissioning or operational instructions. Delivery is made to the address provided by the customer during the ordering process. If no recipient is present at the delivery address provided at the time of ordering, a delivery notice will be left in the letterbox and any costs for redelivery shall be borne by the buyer. SPARK-IN does not deliver to hotels, campsites, military bases or PO boxes and reserves the right to refuse any order where the delivery address is not compliant. Delivery charges are calculated based on the delivery address provided at the time of ordering and on the total order value, and are quoted inclusive of all taxes. Delivery is free for orders of 15,000 euros or more (excluding VAT) to mainland France only, unless otherwise stated on the website. For reasons of availability, an order may be dispatched in several instalments.

Article 6 EN_DASH TRANSPORT

Where deliveries are made via a carrier, the goods are transported at the buyer's risk, regardless of the method or conditions of dispatch. The buyer must, without fail, inspect the goods upon receipt in the presence of the carrier and must, without fail, note any reservations in writing on the consignment note, if necessary, even in the case of carriage paid shipments. Unless otherwise agreed, the seller is free to choose the carrier. In the event that the goods are damaged, the buyer must refuse them. In the event of a parcel being lost in transit, the time taken to investigate may vary depending on the carrier and can take from one week to two months. If reservations are made upon receipt, these must be declared by registered post to the carrier within a maximum of 48 hours and a copy sent within the same timeframe to SPARK-IN - Orders Department - 7, rue Paul Cézanne 10120 Saint Germain

Article 7 - RIGHT OF WITHDRAWAL RESERVED FOR PRIVATE INDIVIDUALS

Under the conditions set out in Article L.121-16 of the French Consumer Code, in the context of distance selling and in accordance with the Harmon Act, the buyer has a withdrawal period of 14 clear days from the delivery of their order. To exercise this right, the buyer must return the goods at their own expense and risk, in their original condition and packaging, and enclose the invoice. Failing this, the returned parcel will be refused. Under the right of withdrawal reserved for private individuals, SPARK-IN will refund the buyer by cheque within 30 days of receiving the returned items. If a returned item is found to be incomplete or damaged, a price reduction will be applied based on the assessment carried out by the SPARK-IN after-sales service. The buyer will then be informed of the amount of this reduction by post.

Article 8 - COMPLAINTS

Any return of goods requires the prior consent of SPARK-IN and the obtaining of a return number. Complaints relating to a defect in the goods delivered, an inaccuracy in the quantities, or an incorrect item reference compared to the accepted offer or the order confirmation by the seller, must be made to SPARK-IN by registered post within 48 hours of receipt of the goods, without neglecting, where necessary and in accordance with Article 6, any claims against the carrier; failing this, the buyer's right to make a claim shall lapse. The buyer's full contact details, a description of the item(s) concerned, their serial number(s) and the invoice or delivery note number corresponding to the items described must be included in the registered letter. The seller shall send the buyer, by the means it deems most appropriate, a return authorisation and a return number. Once the return number has been obtained, the buyer has a period of 7 days to dispatch the item(s) concerned, complete and in their original packaging in perfect condition. The return of the goods shall be at the seller's expense within one month of the order date. This return shall be refunded by cheque by the seller based on the cost of a return via a pre-paid Coliposte parcel from La Poste. After this one-month period, the return costs shall be borne by the buyer. The buyer must enclose a photocopy of the invoice with the parcel and mark the parcel(s) with the words 'SAV' and the return number provided by the seller. Failure to do so will result in the returned parcel being refused. In the absence of an agreement, any returned goods will be held for the buyer at their own expense and risk, with all transport, storage and handling costs being borne by the buyer.

Article 9 EN_DASH WARRANTY

All products supplied by SPARK-IN are covered by the statutory warranty provided for in Articles 1641 et seq. of the Civil Code. Our products are guaranteed for 1 year for parts and labour. For parts, you must contact us in advance and, if we agree, return them (unless we specify otherwise) at your own expense.

If our checks confirm the fault, we will replace the part. For labour, the customer must also contact us in advance. Unless otherwise authorised by us, the warranty is carried out at our workshops in Saint Germain (10). Transport (return journey) is at the buyer's expense.

In all cases, any claims, requests for exchange or refund must be made with our prior agreement.

The seller shall not be liable under the warranty for faults or damage resulting directly or indirectly from the following: - Any unprotected or prolonged storage - Any negligence, handling error, maintenance or use of equipment not in accordance with the seller's or manufacturer's technical specifications or, more generally, faulty or careless use. - Any addition of supplementary devices or accessories to the equipment, or the use of any parts necessary for the operation of the equipment that do not comply with the seller's or manufacturer's technical specifications - Any mechanical, electronic, electrical, hydraulic or other modifications or alterations made to the equipment or its connection devices by any third party. In the event of the manufacturer's bankruptcy or inability to supply, the buyer may not seek recourse against the seller. SPARK-IN shall not be held liable for any indirect damages that may arise from the purchase of the items.

SPARK-IN guarantees the buyer, in respect of any hidden defects that may affect the delivered products, only in the context of replacing defective items or parts rendering them unfit for their intended use, without the buyer being able to hold SPARK-IN liable for any harmful consequences that such hidden defects might have caused. Return postage costs remain the sole responsibility of the buyer. Machines designed and manufactured by SPARK-IN/REGISTERED_TRADEMARK are guaranteed for private use, whether personal or professional. Any rental activity, whether commercial or free of charge, with or without a driver, whose main purpose is the provision of equipment manufactured by SPARK-IN, immediately voids the warranty on such equipment.

Article 10 - USE OF THE EQUIPMENT

Our machines are designed for controlled professional use by trained operators under the responsibility of their operator. They are not intended for hire. Any provision to third parties as part of a lending or hire arrangement constitutes improper use and will result in the suspension of the manufacturer's warranty.

The customer undertakes to use the equipment in accordance with current standards and the instructions supplied with the equipment. The customer shall only use the equipment after having read the instructions in full and undertakes to comply with them strictly. Compliance with safety rules, amongst other things, is imperative. In the event of insufficient technical knowledge, the customer undertakes to attend training courses provided by a competent professional who is insured for this type of work. The equipment may be subject to improvements or specific standards. The customer undertakes to keep abreast of these standards and to upgrade their equipment accordingly.

Article 11 - DATA SHEETS

All the information contained in the fact sheets (advice, best practices, techniques, etc.) available on the SPARK-IN website reflects experience that complements other sources of knowledge available to the user. Decisions taken by the user shall be those appropriate to their own circumstances and shall therefore not engage the liability of SPARK-IN. Reproduction, even in part, of the fact sheets or any other editorial content is prohibited without the prior authorisation of SPARK-IN.

Article 12 - SAFETY

The purchaser undertakes to use the equipment in accordance with the manufacturer's instructions. The customer shall only use the equipment after having read the user manual in full, which they undertake to follow scrupulously, and after having completed the necessary safety and operating training. They shall also ensure that they are duly authorised to operate machinery, particularly in the case of professional use.

Article 13 - RETENTION OF TITLE

Pursuant to the Act of 12 May 1980, title to the goods delivered to the buyer shall not pass until full payment has been made of the principal sum and any ancillary charges, or other instruments issued for the purpose of settling the price. During the period from delivery to the transfer of title, the risks of loss, theft or destruction shall be borne by the buyer. Failure by the buyer to fulfil their payment obligations shall entitle the seller to demand the immediate return of the goods delivered at the buyer's expense and risk.

Article 14 - TERMINATION CLAUSE

In the event of the buyer's failure to comply with any of their obligations, the sale shall be automatically terminated and the goods shall be returned to the seller at the seller's discretion, without prejudice to any damages the seller may claim from the buyer, within 48 hours of a formal notice remaining without effect. In this case, SPARK-IN is entitled to claim from the buyer a lump-sum compensation of 30% of the sale price.

Article 15 - JURISDICTION CLAUSE

Any disputes relating to the formation, performance or termination of the contractual obligations between the parties which cannot be settled amicably shall be submitted to the jurisdiction of the Commercial Court of TROYES, within whose jurisdiction the seller's registered office is situated, irrespective of the terms of sale and the method of payment accepted, even in the event of third-party proceedings or multiple defendants, the seller reserving the right to bring proceedings before the court with territorial jurisdiction over the buyer's registered office. This contract is governed by French law. The application of the Vienna Convention on the International Sale of Goods is expressly excluded.
