## MEETING OF THE CITY COUNCIL OF

# THE CITY OF HOMEWOOD, ALABAMA

# June 13, 2022

The City Council of the City of Homewood, Alabama convened in Regular Session on Monday, June 13, 2022, at City Hall at 6:00 p.m.

At this time, Mayor McClusky presented Proclamations to Joy Beth Smith and Beverly Leboeuf for their BZA service.

Mayor McClusky then presented a Proclamation to Wyatt Pugh for being named Code Official of the Year.

The invocation was given by Councilor Smith, after which the pledge of allegiance was given.

The meeting was called to order by President Wyatt at 6:08 p.m.

Upon Roll Call, the following were present: Andy Gwaltney, Melanie Geer, Carlos Alemán, Andrew Wolverton, Walter Jones, Barry Smith, Jalete Nelms, Jennifer Andress, John Hardin, and Alex Wyatt, constituting a quorum of Council members. Also present were: Mike Kendrick, City Attorney; and Melody Salter, City Clerk; J.J. Bischoff, Chief of Staff; and Mayor Patrick McClusky. Absent: Nick Sims.

At this time, Councilor Wolverton moved to dispense with the reading of the Minutes of the Council Meeting of May 23, 2022 and approve them as presented. Councilor Smith seconded the motion.

President Wyatt asked if the Council had any questions or comments regarding the motion. There was no response from the Council.
