MEETING OF THE CITY COUNCIL OF

THE CITY OF HOMEWOOD, ALABAMA

July 25, 2022

The City Council of the City of Homewood, Alabama convened in Regular Session on Monday, July 25, 2022, at City Hall at 6:00 p.m.

The invocation was given by Councilor Gwaltney, after which the pledge of allegiance was given.

The meeting was called to order by President Wyatt at 6:08 p.m.

Upon Roll Call, the following were present: Andy Gwaltney, Melanie Geer, Carlos Alemán, Andrew Wolverton, Nick Sims, Barry Smith, Jennifer Andress, John Hardin, and Alex Wyatt, constituting a quorum of Council members. At this time, Councilor Smith moved to dispense with the reading of the Minutes of the Council Meeting of July 11, 2022 and approve them as presented. Councilor Andress seconded the motion.
