MEETING OF THE CITY COUNCIL OF

THE CITY OF HOMEWOOD, ALABAMA

October 27, 2025

The City Council of the City of Homewood, Alabama convened in Regular Session on Monday, October 27, 2025 at City Hall at 6:00 p.m.

At this time, the Mayor presented a proclamation for National Pharmacist Month.

The Mayor then presented a proclamation for Councilor John Hardin to honor his service to the City.

The meeting was called to order by President Jones at 6:02 p.m.

The invocation was given by Bo Seagrist, City Clerk, after which the pledge of allegiance was given.

At this time, Councilor Smith moved to dispense with the reading of the Minutes of the Council Meeting of October 13, 2025 and approve them as presented. Councilor Sims seconded the motion.
