MEETING OF THE CITY COUNCIL OF

THE CITY OF HOMEWOOD, ALABAMA

November 14, 2022

The City Council of the City of Homewood, Alabama convened in Regular Session on Monday, November 14, 2022, at City Hall at 6:00 p.m.

The invocation was given by Robert Burgett, Finance Director, after which the pledge of allegiance was given by Junior Girl Scout Troop 26003, Edgewood Elementary Fifth Graders.

The meeting was called to order by President Wyatt at 6:06p.m.

Upon Roll Call, the following were present: Andy Gwaltney, Melanie Geer, Carlos Alemán, Andrew Wolverton, Nick Sims, Walter Jones, Barry Smith, Jennifer Andress, John Hardin, and Alex Wyatt, constituting a quorum of Council members. Also present were: Mike Kendrick, City Attorney; and Melody Salter, City Clerk; and J.J. Bischoff, Chief of Staff. Absent: Jalete Nelms.

At this time, Councilor Smith moved to dispense with the reading of the Minutes of the Council Meeting of October 24, 2022 and approve them as presented. Councilor Gwaltney seconded the motion.

President Wyatt asked if the Council had any questions or comments regarding the motion. There was no response from the Council.

On a voice vote, the motion carried without dissent.

Councilor Andress moved to appoint Anita Morgan to the Homewood Environmental Commission. Councilor Hardin seconded the motion.
