MEETING OF THE CITY COUNCIL OF

THE CITY OF HOMEWOOD, ALABAMA

November 22, 2021

The City Council of the City of Homewood, Alabama convened in Regular Session on Monday, November 22, 2021 at City Hall at 6:00 p.m.

The invocation was given by Dr. Andy Wolfe, Pastor Emeritus, after which the pledge of allegiance was given.

The meeting was called to order by President Wyatt at 6:07 p.m.

Upon Roll Call, the following were present: Andy Gwaltney, Melanie Geer, Nick Sims, Walter Jones, Barry Smith, Jalete Nelms, Jennifer Andress, John Hardin, and Alex Wyatt and constituting a quorum of Council members. Also present were: Mike Kendrick, City Attorney; and Melody Salter, City Clerk; J.J. Bischoff, Chief of Staff; and Mayor Patrick McClusky. Absent: Carlos Alemán and Andrew Wolverton.

At this time, Councilor Smith moved to dispense with the reading of the Minutes of the Regular Called Council Meeting of November 8, 2021 and approve them as presented. Councilor Gwaltney seconded the motion.

President Wyatt asked if the Council had any questions or comments regarding the motion. There was no response from the Council.

On a voice vote, the motion carried without dissent.

At this time, President Wyatt asked for Board openings and nominations.

President Wyatt then stated that the application period for the Ward 1 Homewood Environmental Commission opening would be extended until December 6, 2021 at 4:30 p.m.

At this time, President Wyatt added the following items to the Committee Referral Agenda: Item No. 29.11 21 – Request for consideration for work in the right-of-way at 126 Barbers Ct – Cale Smith, City Engineer – Public Works Committee and Item 30.11.21 – Request for consideration in reduction of sales for 307 Oxmoor Road due to Jeff.
