

# CITY OF HOMEWOOD MAYOR'S BUDGET 2022-2023

GENERAL, CAPITAL, DEBT, AND SPECIAL REVENUE FUNDS

#### FY 22-23 HIGHLIGHTS



Payroll is budgeted with merit increases of \$305,473 before taxes and pension.

An estimated 5% increase in LGHIB premiums with the City paying 100 % of the increase at a yearly cost of \$198,518



The Mayor's budget does not have money allocated for an annual bonus, although a request will be made to Council to consider before year-end if there is a surplus



The City's pension factor is 16.39 % at a cost of \$3,755,293 for FY 22-23



The Mayor's budget does include a 5 % COLA at an approximate cost of \$1,200,000 before taxes, workers compensation and pension
