

**ORDINANCE NO. 2958**

**AN ORDINANCE TO RESERVE OR LIMIT THE PARKING IN THE PARKING SPACES ADJACENT TO THE PLAZA IN FRONT OF HOMEWOOD CITY HALL ON 19<sup>TH</sup> STREET SOUTH; AND TO PROVIDE PENALTIES FOR VIOLATION THEREOF.**

**BE IT ORDAINED BY THE CITY COUNCIL OF HOMEWOOD, ALABAMA, AS FOLLOWS:**

**Section 1.** That it shall be unlawful for any person, firm, corporation or association to park any motor vehicle as defined in the Highway Code of the State of Alabama in the two (2) parking spaces in front of Homewood City Hall adjacent to 19<sup>th</sup> Street South as depicted in Exhibit A attached hereto.

**Section 2.** That the two (2) parking spaces identified in Section 1 above are to be reserved and to be used exclusively by the Homewood Police Department, which Police vehicles will provide access to the Homewood Police Department substation located on the first floor of Homewood City Hall.

**Section 3.** That the Chief of Police for the City is authorized and directed to erect and install or cause to be erected and installed on 19<sup>th</sup> Street in the parking spaces identified in Exhibit A and referred to in Section 1 above appropriate lines, markings and/or limited parking signs at the places described in Section 1.

**Section 4.** That the violation of any section of this Ordinance shall constitute a misdemeanor, and any person, firm or corporation violating the previous thereof, on conviction, shall be punished as provided by Section 1-8 of the Code of Ordinances of the City of Homewood adopted and approved by the City Council and Mayor of the City, or as the same may hereinafter be amended.

**Section 5.** That if any part, provision or section of this Ordinance is declared unconstitutional or invalid by any court of competent jurisdiction, all of the parts, provisions or sections of this Ordinance not thereby affected shall remain in full force and effect.

**Section 5.** That this Ordinance shall become effective immediately upon its adoption by the City Council, approval by the Mayor, or as otherwise becoming law.
