

ORDINANCE NO. 2948

**AN ORDINANCE TO PROVIDE FOR THE APPOINTMENT,
NOTIFICATION AND COMPENSATION OF OFFICERS TO HOLD THE
RUNOFF ELECTION TO BE HELD ON SEPTEMBER 23, 2025**

BE IT ORDAINED BY THE CITY COUNCIL OF HOMEWOOD, ALABAMA, as follows:

Section 1. That, pursuant to the provisions of Ala. Code §§ 11-46-24 and 11-46-27 (1975), the following named persons be and they are hereby appointed as officers to hold the runoff municipal election to be held on September 23, 2025, in the City of Homewood, Alabama, namely:

Section 2. That the Mayor be and is hereby authorized and directed to publish or cause to be published a list of the election officers appointed as aforesaid and the voting places for which

said officers have been appointed by posting same at three (3) public places in the City of Homewood at least ten (10) days prior to said election.

Section 3. That the Mayor shall notify, or cause to be notified, each of the officers named in Section 1 hereof of their appointment, which said notice shall be served upon them by the Chief of Police or by any police officer of the City of Homewood, Alabama.

Section 4. That the Mayor and City Clerk be and they are hereby authorized and directed to pay, or cause to be paid, out of the general funds of the City the fees set by the Acts of the Legislature for the State of Alabama for elections held in Jefferson County, Alabama, for the same or similar election officials and the election of officers herein appointed on proper proof of service rendered by said officers at said election.

Section 5. That the Chief of Police, pursuant to and in the manner prescribed by Ala. Code § 11-46-28(i) (1975), shall preserve good order at said municipal election.

Section 6. That this Ordinance shall become effective immediately upon its adoption by the City Council, approval by the Mayor, or as otherwise becoming law.
