DISASTER FOOD ASSISTANCE Are You Eligible for D-SNAP?

Were you affected by the recent wildfires and windstorms in Los Angeles County?

You might qualify for **Disaster Supplemental Nutrition Assistance Program (D-SNAP)** to help buy food.

Benefits: How Much Help Can I Get?

- **\$250 to \$1,500** based on household size and income
- One month of food benefits via EBT card, usable at **grocery stores and farmers markets**

Application Period: When to Apply?

- **February 10 – 14, 2025 – and – February 18 – 19, 2025**

Eligibility: Who Can Apply?

- **LIVED - or - WORKED** in an **eligible zip code** during the disaster (**list of Zip Codes on reverse**)
- Households who **lost income, lost food**, or had **unexpected disaster-related expenses**
- You do **NOT** need to be a current SNAP recipient to apply

Application: How to Apply?

Option 1: By Phone

- Available 8:00 AM – 5:00 PM during the application period

Option 2: In Person

- Locations include Pasadena, Los Angeles, and many more (**list of Locations on reverse**)
- Operating Monday – Friday, 8:00 AM – 5:00 PM

Requirements: What Do I Need to Apply?

- **Proof of identity** (ID, driver's license, or other identification)
- **Information on income, expenses, and losses** due to the disaster
- **Proof of residency** in an eligible ZIP code (if available)

Important Notes: Anything More to Know?

- **If you already receive SNAP, you might also be eligible for additional assistance**
- Benefits must be used within the required timeframe
- Applying does NOT affect your immigration status
