Our services include: consultation with family and others; our directors are available by way of phone twenty four hours or by in-person appointment including holidays and weekends; personal and professional supervision of arrangements and directions as desired, we do have interns on staff who are learning that may also participate in the arrangements; custody of the body; preparing, recording and filing vital statistical forms, such as the death certificate; general administration record keeping as required by the state; overhead expenses relative to our facility such as insurance, maintenance, utilities, licensing fees, real estate and personal property taxes and state or local inspection fees.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) Certain funeral services may be provided off-premises by other funeral service providers.

EMBALMING

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Local service is 25 miles, beyond 25 miles an additional fee of \$2.50 per mile will be added.

There will be no procession to Albert G. Horton, Jr. State Veterans Cemetery the distance, construction, and the traffic do not allow for a safe procession. Occasionally police have been arranged by family however, none of the motor equipment owned by Graham Funeral Home will be part of procession. Police are no longer allowed to cross city lines and if a procession is requested it will be subject to coordination with all cities and will be billed accordingly.

Due to the fact the following packages are mandated by the FTC, to meet the requirement of "Without Ceremony" we will not arrange for any services including requesting of military honors, or scheduling of the cremated remains for burial. FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME

Our charge includes: basic services of funeral directors and staff; a proportionate share of overhead costs; transfer of remains to funeral home; and embalming.

Refrigeration must take place 48 hours after we take custody of remains. In most cases your cemetery will not be able to accommodate the burial within the 48 hours as required by the Commonwealth of Virginia, therefore the refrigeration fee of \$495 will be added.

Cash Advance items such as, certified copies of the death certificates, obituary (we will assist in placing obituary in local paper and on our website, however, it must be emailed), etc.; would be added to the above costs.

DIRECT CREMATION \$3,275

Direct Cremations range from \$3,275 to \$20,130

Our charge for direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; local transfer of remains to funeral home; private family identification up to ten family members; and crematory fee (if deceased is 301 up to 349 lbs there will be an additional fee of \$150; if deceased is over 350 lbs there additional fee will be \$300)

It does not include use of facilities other than for identification; Refrigeration must take place 48 hours after we take custody of the remains and is required by the Commonwealth of Virginia. Refrigeration is for four days, additional fees may apply beyond this timeframe. Appointments are set Monday-Friday during the hours of 10a.m.—3p.m. A \$400 overtime fee will apply when a family request to make arrangements with a director after 3p.m. or on the weekend for a direct cremation.

State and Local Laws do not require a casket for direct cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials with or without an outside covering. Virginia also requires positive identification prior to cremation. When the death occurs, if the family and Graham Funeral Home staff are present for the transfer of remains to the funeral home, there will be no further viewing unless additional services have been purchased. A complete price list will be provided at the funeral home; they are described on the Casket Price List.

The following items will be added to the Statement of Funeral Goods and Services if applicable; Virginia sales tax for merchandise; cash advance items such as obituary, police, Virginia Medical Examiner fee, death certificates, honorariums, cemetery or church fees, etc.

The Federal Trade Commission Rule allows for you to purchase a casket or urn anywhere you choose. The staff of Graham Funeral Home will only transfer cremated remains to an urn, keepsake or jewelry purchased from Graham Funeral Home. This is to limit our liability of damage to a container we cannot replace.

Certain funeral services may be provided off-premises by other funeral service providers. These services may include a discount and will be retained by Graham Funeral Home. We also partner with Tidewater Community College to allow students to participate with all aspects of preparation including embalming under the direct supervision of a licensed funeral director and embalmer.

PAYMENT POLICY

We are a small independent business providing services and merchandise and are totally dependent upon our clients for prompt payment. Graham Funeral Home does not offer any type of financing and we are not able to wait for an estate to settle therefore, payment is required prior to scheduling services.

- Cash or Check
- 2. Insurance policies: policies will be serviced by 3rd Party Financial Service providers. This provider will take an assignment on the policy for funeral expenses. A processing fee up to 4.5% will be charged by this provider and will be deducted from the insurance proceeds, based on the total due on your Statement of Funeral Goods and Services for example \$12,000 bill the average fee would be \$550. The verification process usually will take up to 48 hours, depending on your insurance company, it has taken up to ten business days. Should you wish to wait for this verification is out of our control and is dictated by your insurance company, there also will not be any additional fees for the delay. The remaining insurance proceeds will be mailed to the beneficiary by check from the insurance company. All insurance companies are different, and it is not uncommon to take up to 90 days to receive remaining proceeds from insurance.

If your insurance company will not cooperate and you choose not to have policy serviced by a 3rd party provider, you will need to select another form of payment.

- 3. **Credit Cards:** We accept Visa, MasterCard and Discover there will be a 3% processing fee added to the total due on your statement of funeral goods and services.
- 4. **Preneed Trusts:** Preneed trusts that are transferred from another funeral home in most cases will cover cost however, your family may be responsible for any remaining balance when the trust funds do not cover the current retail at Graham Funeral Home.
