The Boost Pad equips emerging entrepreneurs with the strategic guidance and support needed to develop innovative solutions, build sustainable enterprises, and advance economic mobility throughout Charlotte.

Next Level Accelerator Cohort Program (flagship accelerator) | In 2025, The Boost Pad's Next Level Accelerator produced strong, measurable outcomes for under resourced founders in Charlotte, NC. Across Cohort 10 and Cohort 11, 52 individuals applied, 35 were accepted, 31 enrolled, and 25 completed the accelerator, resulting in a completion rate above 80%. Participants were 80% Black, 64% women, and 76% from low to moderate income households (annual income at or below 63,000), meaning the program reached the very entrepreneurs least likely to access bank financing or traditional accelerator support. At baseline, participating businesses reported 196,000 in prior 12 month revenue and 15 existing employees; post program projections estimate 1,527,100 in net revenue and 78 expected workers within 12 months. With an approximate combined program cost of 120,000, the accelerator achieved an estimated cost of 4,800 per graduate, 1,538 per projected job, and a 12.7:1 revenue leverage ratio (about 0.08 in program cost per projected revenue dollar). Participants reported a Net Promoter Score of 91 and 90% reported increased confidence in their ability to grow their business, a leading indicator of risk tolerance, customer acquisition, and investment readiness. To generate these outcomes, The Boost Pad operates the Next Level Accelerator Cohort Program, a 14 week flagship accelerator followed by continued support. The program is designed for low to moderate income, Black, and women founders building income producing, job creating businesses. Each cohort receives a structured curriculum in business model development, revenue strategy and pricing, financial literacy, customer acquisition, and operational readiness. Learning is delivered through weekly workshops, cohort discussions, and 1:1 office hours with an entrepreneur in residence and subject matter experts. Founders also gain access to mentors, pro bono legal resources, and a peer network that extends beyond graduation. These activities directly advance the organization's exempt purpose by using entrepreneurship as a pathway to economic mobility, job creation, and stronger neighborhood economies.

Entrepreneurial Mindset & Founders' Training | In 2025, The Boost Pad's education and community building programs deepened founders' skills and long term success beyond the accelerator cycle. Founders received 590 hours of entrepreneur in residence training and advisory support, attended 366 individual networking events, and participated in an Access to Capital convening with 186 attendees. Across programs, 90% of participants reported increased confidence in their entrepreneurial abilities, and the organization recorded a Net Promoter Score of 91, indicating a high level of satisfaction and perceived value. These outcomes show that founders are not only starting businesses but also gaining the mindset, networks, and support systems needed to sustain and grow them. The Boost Pad achieves this through its Entrepreneurial Mindset & Founders' Training and Founder Community & Mentorship programs. Entrepreneurial Mindset & Founders' Training offers both live workshops and self paced digital content focused on idea validation, business model design, financial fundamentals, legal and operational readiness, and launch planning. The curriculum is specifically tailored for first time and under resourced founders, using practical tools and accessible language. The Founder Community & Mentorship program maintains support before, during, and after the accelerator via peer cohorts, alumni engagement, and structured mentorship. Founders are matched with advisors and an entrepreneur in residence for individualized guidance and accountability, and they are invited to regular networking events with community partners and ecosystem leaders. Together, these programs build the entrepreneurial knowledge, social capital, and long term relationships that undergird sustainable income growth and job creation for low to moderate income founders.

Founder Community, Mentorship, and Startup Currency Resource Grants | The Boost Pad's Startup Currency and capital access initiatives convert philanthropic dollars into direct, catalytic resources for under resourced entrepreneurs. In 2025, these efforts helped founders secure grants for critical needs such as legal formation, intellectual property protection, marketing, and infrastructure upgrades. Program case studies demonstrate tangible impact: one founder used a 5,000 Startup Currency award to cover patent related legal costs and subsequently secured a 10,000 NC IDEA Seed grant; another leveraged Boost Pad funding and support to add multiple new client accounts (including a major school contract), hire employees, and reinvest in software and marketing operations. These outcomes illustrate how early, flexible capital and targeted support unlock follow on funding, business growth, and job creation for low wealth founders who are typically excluded from traditional capital markets. To drive this impact, The Boost Pad operates Startup Currency Resource Grants and related capital access programs, including pitch competitions and the Nitro Fund. Startup Currency provides small, flexible grants, often awarded through cohort pitch nights, to offset high impact startup and growth expenses. Pitch events also connect founders with potential funders, customers, and professional service providers. The Nitro Fund serves as a venture philanthropy vehicle that deploys "startup currency" as grants, recoverable capital, or equity investments to founders demonstrating traction and a path to sustainability, initially seeded by corporate sponsorship and grown through donations and potential investment returns. Complementary activities include Access to Capital events, grant writing support, pro bono legal services, and introductions to mission aligned lenders. Collectively, these tools ensure that founders not only know how to grow their businesses, but also have the financial runway and professional services required to execute, advancing the organization's charitable purpose of expanding economic opportunity and job creation in under resourced communities.

Participants contribute 200 at enrollment and, upon successful completion, receive a 400 payment. Startup Currency awards of approximately 1,000-10,000 are made to pitch-competition winners; volunteer judges score founders using a standardized rubric and management approves awards and oversees disbursement. Each recipient signs a grant agreement with an intended-use budget, and awards over 1,000 are often paid in tranches tied to interim progress updates. Recipients are asked to provide business updates every six months for two years. To the best of the organization's knowledge, no 2025 funds were misused or diverted. The Boost Pad maintains internal records of all individual recipients and award amounts that reconcile to the totals reported on Schedule I.

In 2021, The Boost Pad received a restricted donation to support entrepreneurial investment activities and used these funds to make a 25,000 investment for a 2.5% equity stake in Cellular Farms Inc. The investment terms were consistent with those of other investors in the same round and were reviewed and approved by the board under the organization's conflict of interest policy. Due to subsequent changes in Cellular Farms' financial and operational status, the board determined that the investment should be written down to 50% of its original value; as of December 31, 2025, it is carried at 12,500. Cellular Farms has since ceased active operations and the organization's equity interest has been rolled into a successor company. The board is aware of these developments and believes there remains a possibility of recovery. Steven Lewis, co executive director, retains a 35% ownership interest but holds no management role.

For the year ended December 31, 2025, The Boost Pad reported a decrease in net assets primarily due to planned program investments that exceeded current year revenue. Total revenue was approximately 137,800, while total expenses were approximately 219,800, resulting in an operating deficit of about 82,000. The deficit reflects intentional spending on expanded accelerator programming, Startup Currency awards, curriculum, and staffing to serve more under resourced founders, and was funded from net assets accumulated in prior years. As a result, net assets without donor restrictions decreased from 93,501 at the beginning of the year to 11,549 at year end. Management and the board are monitoring cash flow and anticipate reducing the deficit in future years through a combination of fundraising and expense management.
