Although these disclosures are similar, they are not exactly the same. This General Price List contains both sets of the required disclosures. The disclosures required by the FTC, when different from those required by the Department of Health, are preceded by the letters "FTC."

The goods and services shown below are those we can provide our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected.

This list may not include prices for certain items that you select, such as cemetery charges or crematory services, flowers, and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.

Your authorization is required for a funeral home to obtain custody of a body, and a body must be released promptly upon your request.

The Provider of funeral services is required to give price information in person and over the telephone.

A provider of funeral services is prohibited from representing that the deterioration of human remains can be prevented for more than a limited time by embalming, caskets, vaults or outer interment receptacles.

(FTC) "The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected."

(FTC) "This list does not include prices for certain items that you may ask us to buy for you, such as cemetery or crematory services, flowers, and newspaper notices. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected."

Arrangements.....\$1,895

The charge for our services will be added to the total cost of the funeral arrangements you select. However, this charge will not be added to the cost for direct cremation, direct burial, forwarding of remains, or receiving of remains because the prices for those services include this charge.

(FTC) "This fee for our services will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)"

This fee includes the following:

>Personnel available 24 hours a day, 365 days a year to respond to initial call.

>Arrangement conference.

>Coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased.

>Securing of necessary authorizations.

>Also covers overhead, including facility maintenance, equipment and inventory costs, liability insurance and governmental compliance costs.

Preparation of the Body

NOTE: In New York State, embalming is not required by law.

If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for embalming such as a direct cremation or direct burial. If you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be required by the funeral firm.

(FTC) "Except in certain special cases, embalming is not required by law. Embalming may be necessary, however; if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate burial."

Transfer of remains from local place of death to funeral home. Staff Services, Securing necessary authorizations, Transportation of remains to local cemetery. This charge does **not** include additional items of services, merchandise, facility use, and livery that the customer may wish to select.

Immediate burial with container provided by the purchaser.....\$2,795

(all such containers must meet any applicable state or cemetery requirements).

Immediate burial with minimum casket from our facility.....\$2,795

Immediate burial with casket selected from our facility.....\$3,195

(In addition to cost of casket – see Casket Price List for casket prices.)

Receiving Remains From Another Funeral Home:.....\$2,495

This charge includes:

Transportation of remains to the Funeral Home or local place of disposition. Staff Services. Securing necessary authorizations. This charge does **not** include additional items of services, merchandise, facility use, and livery that the customer may wish to select.

Transportation beyond local place of disposition will be billed as livery charges.

Forwarding Remains To Another Funeral Home:.....\$2,495

This charge includes:

Transfer of remains to Funeral Home. Staff Services. Securing necessary authorizations. Transportation to or from local airport or other local place of shipment. Minimum shipping container.

This charge does **not** include shipping charges, additional services, merchandise, facility use, or livery that the customer may wish to select. Transportation beyond local area will be billed as livery or common carrier charges, depending on forwarding location.

DIRECT CREMATION

Pricing includes the local transfer of remains to the funeral home, staff services, securing of necessary authorization, basic local transportation to the crematory, and return of the remains to the funeral home.

NOTE: Charges DO NOT include the cremation fee.

(FTC) "If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials."

>Cash, Check, Money Order, or Credit Card.

>Life Insurance policies collected through Express Funeral Funding. Policies must be assigned to the funeral home. Any policy that is contestable will not be accepted as a viable payment method. Service information will not be determined until Life Insurance proceeds have been confirmed by the funeral home.

In cases where the deceased's estate must stand the burden of paying the funeral expenses, a family representative will be required to pay the funeral expenses and file claim for reimbursement with the loved one's estate.

At least one family representative and Mohawk Valley Funerals and Cremation must mutually agree upon financial responsibility. Please let us know which method of payment you prefer and if you have any questions.
