

Statutory Standardised Price List April 2026

All funeral directors are legally required to publish this Price List for a standardised set of products and services. This is to help you think through your options and make choices, and to let you compare prices between different funeral directors (because prices can vary).

ATTENDED FUNERAL

Funeral director's charges only **£2,470.00**

This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.

- Taking care of all necessary legal and administrative arrangements £ 1195.00
- Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises, office hours) into the funeral director's care £ 200.00
- Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at the funeral director's premises, 26 Abbotswell Crescent, Aberdeen, AB12 5JW £ 375.00
- Providing a suitable coffin – this will be made from wood effect, MDF (Glenshee) £ 550.00
- Viewing of the deceased person for family and friends, by appointment with the funeral director (where viewing is requested by the customer) £ included
- At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle £ 150.00

UNATTENDED FUNERAL

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

- Burial (funeral director's charges only) £1400.00
- Cremation (funeral director's charges plus the cremation fee)² £1475.00

FEES YOU MUST PAY

- For an Attended or Unattended burial funeral, the burial fee.¹ From £ 1063.00
- In this local area, the typical cost of the burial fee for local residents is: For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees. From £ 1273.00
- For an Attended cremation funeral, the resident cremation fee is ^{is} £ 871.00
- In this local area, the typical cost of a cremation for local residents £ 871.00

ADDITIONAL FUNERAL DIRECTOR PRODUCTS & SERVICES

This funeral director may be able to supply a range of optional, additional products and services, or to arrange (on your behalf) for a third party to supply them. Examples include:

- Additional mileage (price per mile) £ 1.90
- Additional transfers of the deceased person's body e.g. to their home, to a place of worship etc. (price per transfer) £195.00
- Collection and delivery of ashes £ 40.00
- Embalming £130.00
- Funeral officiant e.g. celebrant, minister of religion etc, estimate £220.00
- Services supplied outside of normal office hours £150.00

The funeral director can give you a full list of what they can supply. They are likely to charge for these additional products and services, so you may choose to take care of some arrangements without their involvement.

¹ This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

² In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.

Payment Arrangements

We require an upfront payment no less than the value of all third party costs no less than 72 hours prior to the funeral.

The final invoice will be issued the week after the funeral with any outstanding balance due within 28 days.

Our Non attended cremation option must be paid in full, prior to booking of cremation time:

- If a balance remains un-paid at the due date, we may charge you interest at a rate.
- 4% above our Bank's base rate from time to time enforce.
- Calculated on a daily basis from the date of our account until payment.
- Compounded on the first day of each month.

We may recover the cost of taking any action over unpaid invoices.
