TOWN OF KIRBY NOTICE OF HEARING AND SITE VISIT FOR ALTERATIONS TO TOWN HIGHWAY NO. 1

NOTICE IS HEREBY GIVEN pursuant to Title 19 Vermont Statutes Annotated, Chapter 7, as amended, sections 709, 790 and 792, that the Kirby Selectboard will hold a site visit and hearing to consider the Town of Kirby' Selectboard's proposed alterations to the Town Highway No. 1 (Ridge Road) where it runs along Barnes Brook as follows:

- 1. Straightening the road as it runs along Barnes Brook, by shifting the road -- the traveled portion of which is ten (10) foot wide -- to the north by approximately ten (10) feet and installing a four (4) foot wide ditch system along the north edge of the traveled portion. This will require excavating the existing ledge and dirt embankment along the north side of the road a width of approximately seventy (70) feet, and approximately three hundred (300) feet in distance, along the road and resurfacing the road in its new location.
- 2. Restoring the eroded embankment south of the road and north of Barnes Brook. This will require filling and stabilizing the eroded embankment with 65 feet of downslope for a distance of approximately 200 feet along the south side of the road.
- 3. The aforementioned alterations are depicted as Project-5 on the map attached as Exhibit A hereto.

THEREFORE, the Kirby Selectboard shall convene a hearing at the Kirby Town Hall at 346 Town Hall Road in Kirby, on April 28, 2025 at 8:15 am at which time the Selectboard shall open the hearing to describe the Selectboard's proposal to alter the road, its embankments and ditches and to collect a list of attendees. The Selectboard will then adjourn the hearing and proceed to visit the site to view the area to be altered at 8:30 am. The Selectboard will then re-open the meeting at the Town Hall at 9:00 am, to continue the hearing on their aforementioned proposal. During the re-opened meeting, the Selectboard will hear all persons interested in the aforesaid public highway alterations, and finally the Selectboard will determine whether the public good, necessity and convenience of the inhabitants of Kirby require these changes.
