# RULES FOR ARTIFICIAL INSEMINATION FOR PURE CLEVELAND BAY REGISTRATION

The Cleveland Bay Horse Society (CBHS) encourages Pure Cleveland Bay foals to be registered where the recipient mare has been inseminated by fresh, chilled or frozen semen provided that the following rules are strictly adhered to:

#### 1 The Donor Stallion

The donor Cleveland Bay stallion, as with natural covering, must meet all the requirements of the CBHS for natural service in that it must be:

- Registered with the CBHS and be licenced for Pure breeding.
- Have its DNA analysed and the results recorded in the CBHS records.

#### 2 The Semen

The semen used in the insemination must be certified as being the semen of the named donor stallion by a Veterinary Surgeon, or such competent person permitted by law in the country where the insemination occurs (see Part B of the AI Certificate).

#### 3 The Mare Owner

The Mare owner must also certify that the semen is from the donor stallion to the best of his/her knowledge and belief.

## 4 The Recipient Mare

For the foal to be eligible for registration in the Pure Stud Book the recipient mare must meet all of the CBHS requirements for registration, including having her DNA recorded on the CBHS records. This should be done before insemination occurs to ensure registration of the offspring of the mare is possible in the pure stud book. Please check with the CBHS, before you proceed with the insemination that your mare's DNA is recorded, if not then this simple process will have to be undertaken (and the relevant fee paid) before a pure foal can be registered.

### 5 The Progeny

Any resulting foal must be DNA analysed and the parentage confirmed before they will be accepted for registration into the CBHS stud book.

#### 6 Registration

All such registrations must be submitted on the CBHS Pure Bred Registrations form and accompanied by the Society's fully completed AI certificate.
