Rules:

This grant can be applied for by CBHS Overseas (including EU) Members Only (UK Members are not eligible).

The CBHS is offering **£100** per CBHS registered pure mare covered by a CBHS licenced pure stallion in 2026 providing the rules below are fulfilled, and a claim form is completed.

Claims must be made to the CBHS in 2026 as soon as all required paperwork is available, payment will be made as soon as possible thereafter.

1. The application must be for a CBHS pure registered mare to a CBHS pure registered licenced Stallion.
2. The grant is open to CBHS Overseas members only, and the Member must own the mare the claim is made for, or supply evidence of breeding loan/lease.
3. Recipients must undertake to ensure that foals are CBHS registered in the year of birth.
4. A maximum of **2 claims** per stud/prefix/breeder or if no prefix is registered, a maximum of 2 claims per breeder/owner in 2026 (the decision of CBHS is final).
5. No mating that is red on SPARKS sheets for 2026 will be eligible for payment (progeny with an inbreeding coefficient of 0.24 or greater).
6. A covering certificate or AI certificate is required as proof of covering **OR** if the mare is examined for breeding and is found not to be fit to breed, the CBHS must receive a copy of the vet report confirming date of exam and recommendation from the Vet.
7. The names of the mare and stallion used will be recorded and used for research of foals born. This will enable the CBHS to assess the impact of this grant and if any covering is unsuccessful, the owner may be asked for further information, or to follow up with veterinary advice.
8. Applicants will need to complete the application form and return to the CBHS office.

NB If the mare named on this claim form has been the subject of 2 previous claims for a pre-breeding grant (regardless of ownership) and has not produced a live foal as a result of those grants then no further claim for the same mare will be paid.
