## RULES

1. Applicants must be current UK-resident members of the Cleveland Bay Horse Society.
2. The stallion must be owned by a UK resident.
3. The stallion must be a registered, licensed pure Cleveland Bay stallion.
4. Training must be undertaken by a professional training provider.
5. Grants are available for both initial dummy training and refresher training.
6. Livery costs during training are eligible claim items (excessive claims will be discounted, and could result in the rejection of the whole grant claim).
7. Funding is based on actual expenditure paid by the applicant, up to a maximum of £500 per stallion.
8. A maximum of two stallions may be claimed per member.
9. Travelling, mileage and transport costs are not eligible.
10. Claims will only be paid upon receipt of a paid invoice and proof of payment.
11. The Society reserves the right to request further supporting documentation.
12. Claims must be submitted by the 1st of December 2026 unless otherwise agreed in advance by the Society.
13. Grants are subject to the availability of HBLB funding and approval by the Breed Committee of the Cleveland Bay Horse Society.
