

**Arizona Cattle Industry Research & Education Foundation
Grant Boice Hall of Fame Award
Rules & Nomination Form**

Purpose of Award:

The ACIF Foundation Grant Boice Hall of Fame is designed to honor a member of the organization that has given time, service, and talent to the betterment of the Arizona Livestock Associations at the county and/or state levels and is still living.

Selection of Inductees:

One person will be inducted into the Grant Boice Hall of Fame each year. No current member of the Arizona Cattlegrower's Association Executive Committee OR ACIF Foundation Executive Committee is eligible for nomination to the Hall of Fame. Winners will be notified in early summer.

Recognition of Award:

The Grant Boice Hall of Fame Inductees will be recognized during the Annual Summer Convention Awards Ceremony. Each recipient will receive the award honor, a plaque, and their name added to the perpetual plaque.

Selection of Committee:

A committee of five is to utilize whatever method it desires to collect data and make its selection(s). The committee will serve for three years and then rotate off with a new group being selected. The committee will be comprised of ACIF Foundation members or their designee: ACIF President, ACGA Past-President, Agribusiness Trustee, and two other volunteer ACIF Foundation Trustees.

Guidelines for Selection:

This program is designed to give appropriate recognition to those who have made highly significant achievements in livestock or agribusiness. Honorees selected and recommended by the committee shall possess the following criteria:

- 1) have impeccable character;
- 2) have provided truly outstanding leadership affecting Arizona livestock;
- 3) have made noteworthy contributions;
- 4) have received recognition for achievements; and
- 5) recognition should be given to nominees with great accomplishments.

Eligibility:

- Nominations will be accepted from any member or organization in the Arizona Cattle/Livestock Industry or ACIF Foundation.
- Been active and prominent in the work of county/state associations, the Arizona Cattle/Livestock Industry or ACIF Foundation.

Nominating Requirements:

- Complete nomination form (must be typed).
- Recommendation letter supporting nomination from ACGA or ACIF (Foundation) member.
- All application materials must be submitted in one packet to be considered complete.
- **Deadline for nominations: May 15**

3. List industry recognitions of individual.

4. Other activities of the nominee in the community relevant to agriculture (4-H, FFA, government, etc.).
5. Why is the nominee's contribution unique?
6. What are the lasting benefits of this candidate's contributions?
7. Was the nominee innovative or creative in an approach to an agriculture problem, and how did it benefit the industry, either local, state or the ACIF (Foundation)?
