- **GMC Membership** - All individuals submitting petitions for consideration **MUST** be a member of the Global Methodist Church. All cosigners be members of the Global Methodist Church. Groups eligible to submit legislation **MUST** meet the requirements in the Petitions Process Overview document linked above.
