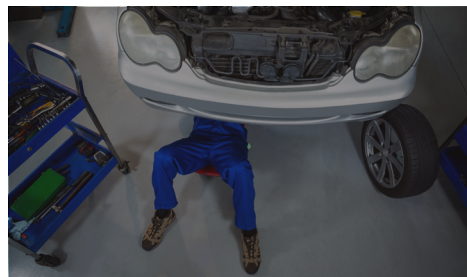

Graded Membership

MASTER MEMBER MMIAME

Required to have the equivalent of up to 1500 hours of learning, training and assessments with trade experience including apprenticeship and either hold an acceptable exemption or pass the IAME examination requirements. Master Members must be able to apply knowledge and skills to demonstrate autonomy, judgement and defined responsibility in known or changing contexts and within broad but established parameters.

MEMBER MIAME

Required to have the equivalent of up to 1200 hours of learning, training and assessments with trade experience including apprenticeship and either hold an acceptable exemption or pass the IAME examination requirements.

ASSOCIATE MEMBER AMIAME

Required to have the equivalent of up to 900 hours of learning, training and assessments with trade experience including apprenticeship and either hold an acceptable exemption or pass the IAME examination requirements.

ASSOCIATE AIAME

Required to have the equivalent of up to 600 hours of learning, training and assessments with trade experience including apprenticeship and either hold an acceptable exemption or pass the IAME examination requirements.

Non-Graded Membership

AFFILIATE: CORPORATE

This category is available for organisations, partnerships or companies who wish to be affiliated with the IAME.

AFFILIATE: PERSONAL

Available to people not necessarily involved in the servicing and repair of motor vehicles, but in related areas, or to persons who have sat the IAME entrance examination and have not satisfied the requirements for graded membership.

STUDENT MEMBERSHIP

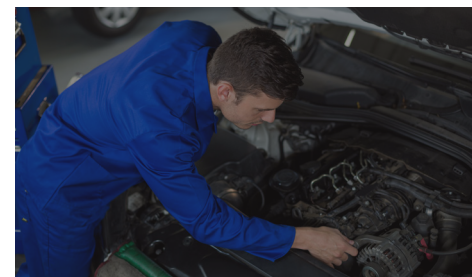
