Connecticut Foodshare Advocacy Update

Advocacy Update: Successes

- CT-NAP Funding increase passed in last year's legislative session
 - \$3 million this fiscal year
 - \$6 million in fiscal year 2027
- The Governor has also allocated \$24 million to food assistance programs in Connecticut to help offset the continued effects of changes to SNAP.





Advocacy Update:2026 Legislative Agenda

Goals for the 2026 legislative session:

- Increase the stability and capacity of the charitable food system in Connecticut
- Support increases in resources for programs that provide cash assistance to neighbors
- Ensure the availability of data on food insecurity in Connecticut to help inform decision making

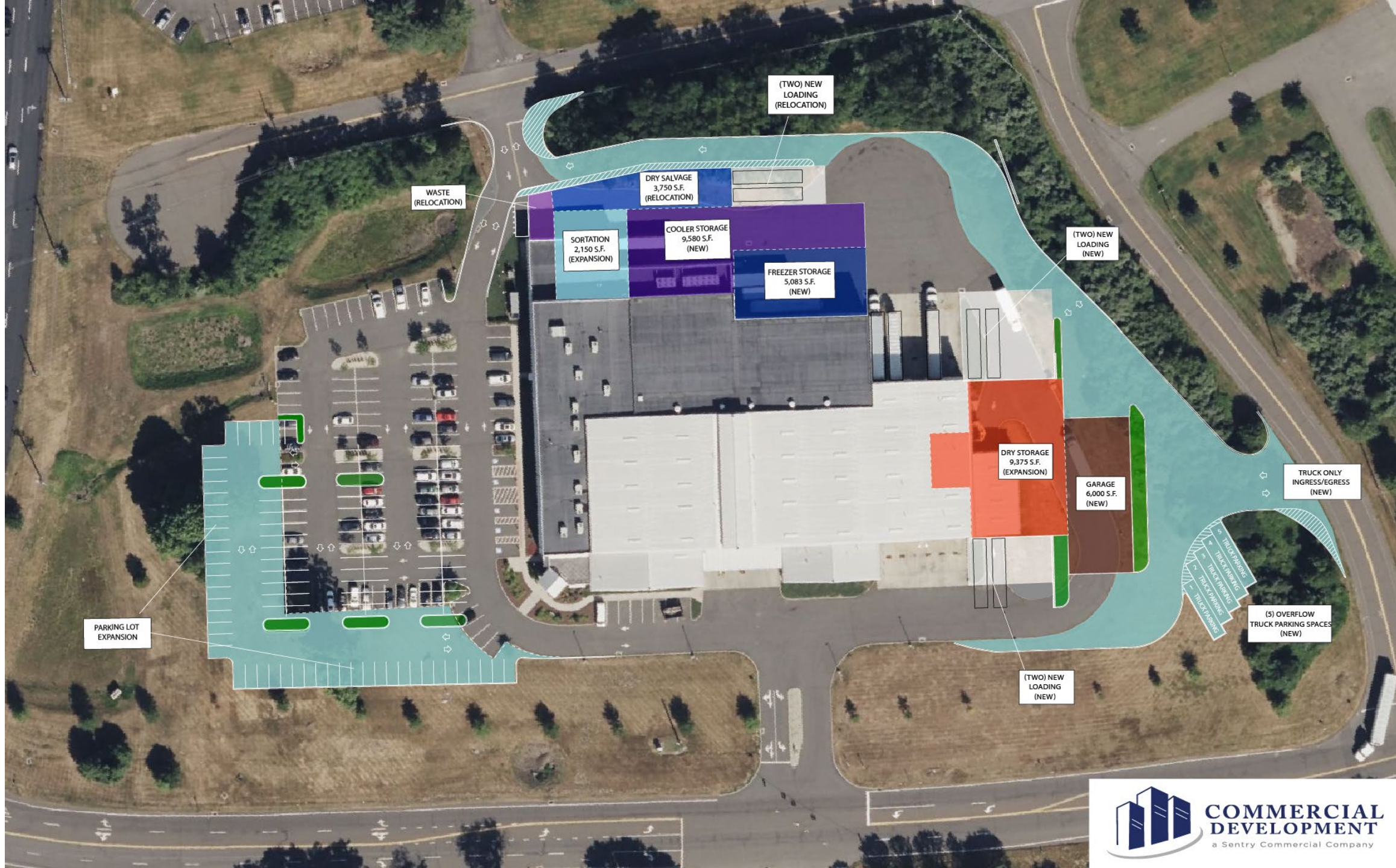

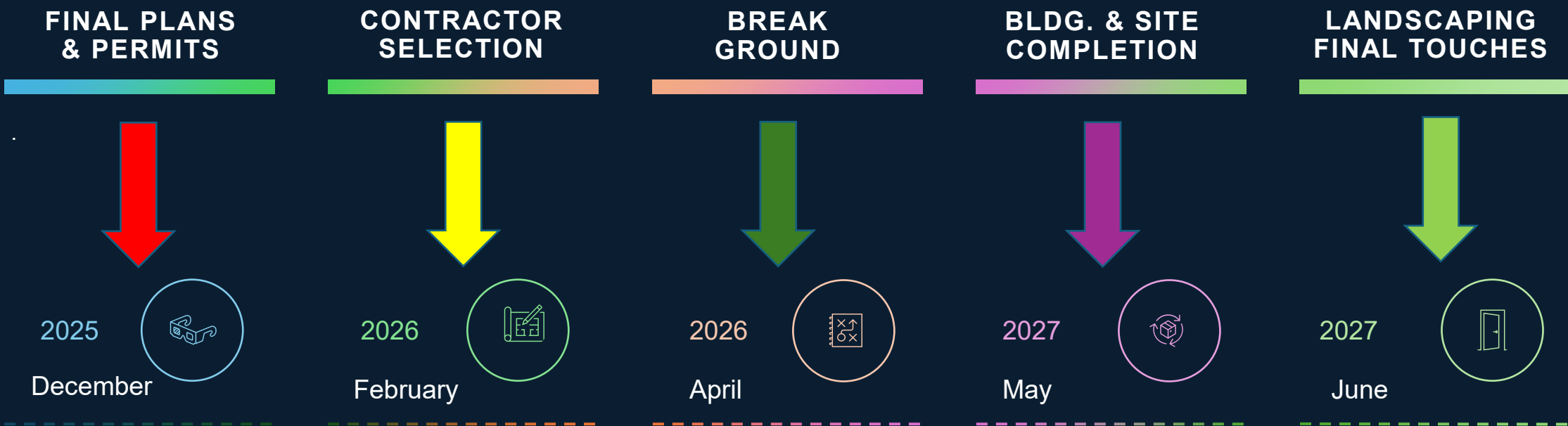

Increased CT-NAP Funds

Plans for increased CT-NAP funds:

- Continue to source fresh eggs
- Increase frozen protein as able depending on freezer space
- Increase dry product
- Currently on order:
 - canned mixed vegetables
 - canned kidney beans
 - canned pears
 - canned peaches
 - canned corn
 - canned pinto beans

Produce

- **Value Added Processing (VAP)** – imperfect produce donated to food banks with fees for transportation/packaging (cost fully covered by Connecticut Foodshare)
 - 4 tractor-trailer loads each week online
 - 1 tractor-trailer load as needed for Mobile and CSFP
- **Local Produce**
 - 15% of CT-NAP funds allocated to purchase produce from local growers
 - Continued efforts to source donated product from local growers and distributors



Retail Rescue

- ▶ Continuing to seek out potential new retailers
- ▶ Working with current donors to increase donations and add categories where possible
- ▶ Retail donors focusing on reducing shrink so have less to donate



Looking Forward

Continued efforts to source as much food from local donors as possible

Focus on fresh produce and protein

Increase culturally connected foods
Including Halal and Kosher

Continue to take advantage of food
available through TEFAP

Utilize feedback from agency partners
to inform purchases – GPP and CT-NAP

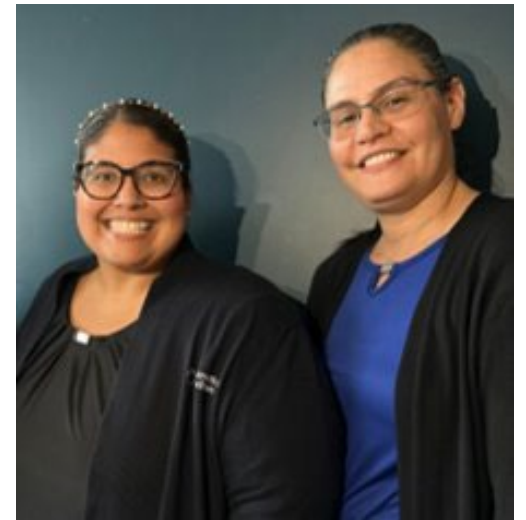
Connecticut Foodshare's SNAP application assistance team helps neighbors:

All assistance is provided over the phone – no need to travel.



SNAP – Changes to Benefit Loading Dates Coming Soon!

Beginning March 1, 2026:

- SNAP benefits will be loaded over the **first 8 days** of the month -- currently first 3 days
- SNAP benefits will now be loaded based on the last two digits of the client's Client ID number – currently first letter of last name

SNAP & CASH

Benefit Loading Dates Are Changing

MARCH 1ST 2026

WHAT'S CHANGING?

- **CASH benefits** will issue on the **first day** of the month
- **SNAP benefits** will issue during the **first 8 days** of the month

HOW? Payment date is based on the **last 2 digits** of the **EBT card** as shown to the right:

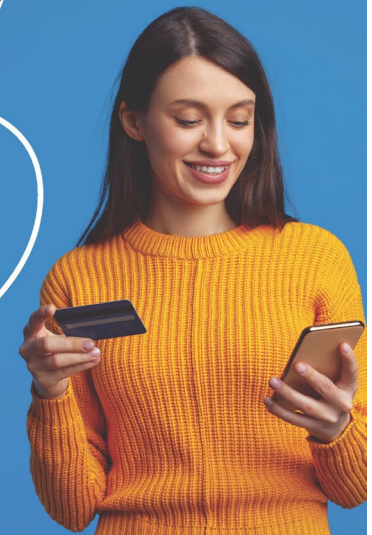
Client ID:	Loading Date
00-12	1 ST of the month
13-24	2 ND of the month
25-37	3 RD of the month
38-49	4 TH of the month
50-62	5 TH of the month
63-74	6 TH of the month
75-87	7 TH of the month
88-99	8 TH of the month

PLAN AHEAD:

Match your Client ID with the day of the month to know when your SNAP benefits will load.

NEED YOUR CLIENT ID?

Use the last two digits of the **Client Number** from your **Connect Card**.
(ex: ID ending in 34 loads on the 3rd)

State of CT Government Shutdown Relief Credits: Expiring March 31

- The State of Connecticut awarded Connecticut Foodshare this **emergency funding** in November to have an immediate impact and help meet growing need during the government shutdown
- If your agency account in Network Hub still has unspent State of Connecticut Shutdown Relief funds, this GPP credit will expire on **March 31, 2026**
- To see if your account has unspent grant funding available, log in to Network Hub and click the **Grants** tab
- Credits are automatically applied to GPP expenses when orders are placed
- If you want to brainstorm ways to make the most of this credit while it's still available, contact your Network Relations Representative

Onsite Partner Support Program:

Apply by February 13

- Request custom capacity-building support at your location from a trained AmeriCorps VISTA
- Support visits will take place over the course of about 2 to 4 weeks this Spring

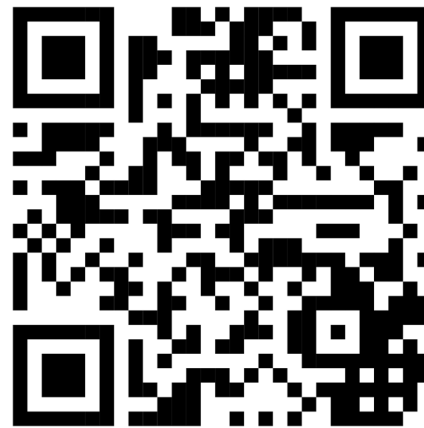
